During her career with the White House, Ms. Rice was active in the policy negotiations and discussions with Congress, state officials, and various private/public organizations. The records within this proposed opening cover the years 1997 to 2000 and are arranged alphabetically. Representative files include records pertaining to budget development and negotiations, childcare enhancement, child support enforcement with an emphasis on computerized state collection tools and procedures, the pursuit of employment rights for the disabled, and fatherhood development. The collection reflects a level of diversity indicative of the emerging communications revolution of the 1990s, containing faxes, electronic mail, "gray literature" from government and non-profit entities, correspondence from policy advocates, articles from various media outlets, memoranda, handwritten notes, and reports.
