OCC Releases CRA Evaluations For 40 National Banks

WASHINGTON, DC -- The Office of the Comptroller of the Currency (OCC) today released a list Community Reinvestment Act (CRA) performance evaluations that became public during the perio of November 15, 2003 through December 14, 2003. The list contains only national banks and insu federal branches of foreign banks that have received ratings. The possible ratings are outstanding, satisfactory, needs to improve, and substantial noncompliance.

Of the 40 evaluations made public this month, 5 were **outstanding**, 34 were **satisfactory**. One **needs to improve.** None were **substantial noncompliance**.
