SUBJECT: Deemed Export Compliance Program --

Annual Certification of Compliance

## Background

The Office of the Inspector General (OIG) Report, "Deemed Export Controls May Not Stop the Transfer of Sensitive Technology to Foreign Nationals in the U.S.," IPE-16176 (Mar. 2004), concluded, "NOAA lacks an overall deemed export control policy to effectively monitor foreign national access to controlled technology." NOAA responded to the OIG report by implementing procedures to identify and track controlled technology and any possible access to this technology by a foreign national. As a result of the effort and hard work across NOAA, we have made great strides in identifying and assessing export controlled technology at facilities with foreign nationals and NOAA critical infrastructure sites. In our review so far, NOAA has found no instances where foreign national access to controlled technology is required to conduct the Agency's business, and therefore no deemed export license applications have been submitted. Unauthorized access has been prevented through physical and IT security measures.

# Annual Certification - Beginning October 2006

The National Oceanic and Atmospheric Administration (NOAA) action plan for responding to the 2004 OIG Report depends upon the continued support of all Line and Corporate Offices. The next step in the process is to institutionalize internal control procedures that will demonstrate and ensure ongoing adherence to deemed export policies and requirements. The attached certification statements are to be submitted on an annual basis to certify accurate and timely completion of required inventories and assessments related to deemed exports.

The first certification statement is to be used at the Line Office/Corporate Office level to report to the CAO. The Deputy Assistant Administrator or Corporate Office Director will sign the certification on behalf of the entire Line or Corporate Office and forward the statement to the CAO. The certification statement and its attachments will reflect data for the previous fiscal year and must be submitted to the CAO by the third week in October. The 2006 deadline is October 20, 2006. A point of contact must be listed for each facility covered by the certification statement. This point of contact is the person responsible for the individual facility assessment.



You are requested to work with your respective Deemed Export Steering Committee representatives to develop an internal reporting structure so that all facilities under your jurisdiction may report to you the status of your foreign national lists and controlled technology assessments accurately and in a timely manner.

To assist you in this effort, the second certification statement provided to you with this memorandum is designed to be used by your contact person at individual facilities. This statement requires more attachments and will assist you in your documentation and record keeping for NOAA's compliance program. These certification statements will be submitted to the Deputy Assistant Administrator or Corporate Office Director to verify compliance.

## Facilities Covered by Certification

As stated above, in 2005, NOAA was required to identify and assess export controlled technology at facilities with foreign nationals and at NOAA national critical infrastructure sites (Priority One sites). For the purposes of the 2006 certification statements, facilities identified in your 2005 foreign national list and controlled technology inventory will serve as the minimum baseline requirement. However, if you conducted controlled technology inventories at additional facilities in 2006 or if you had foreign nationals working at additional facilities in FY06, you are required to include this information in your FY06 certification and your FY06 certification should cover these additional facilities.
