This series of the White House Central Files consists of letters, telegrams and post cards from the general public commenting on various issues which arose during the Eisenhower administrations. The material is arranged by issue, but the files for each issue are usually not indexed or alphabetized. Consequently, correspondence from specific individuals cannot easily be located and the material is best suited for statistical analyses of public reaction to various issues. The volume of mail on specific issues varied widely, from less than one box on minor issues, to over one hundred boxes on major issues such as McCarthyism or segregation. This material, while available for research, is for statistical use only. Individual items are not to be copied, cited or quoted by researchers without being screened by the Library staff. Correspondence was often marked "Ack'd" to indicate that it was unacknowledged by White House staff.

- Boxes 1-56 Greeting cards and letters, usually banded in small bunches with note attached indicating number of cards in each bunch and categorized as "children", "regular", "mutual birthday," etc. Usually marked "Ack'd". No other arrangement.

### **Birthday Greetings, 1960**

- Boxes 1-129 Greeting cards, letters, post cards and telegrams. Usually stamped "Ack'd by card." Usually banded in small bunches. Some bunches have notes attached indicating number of cards in bunch, and categorized as "children," "regular," etc. No other arrangement.

### **Correspondence re: Bricker Amendment**

- Boxes 1-5 Unarranged. Unacknowledged. Often marked "Insufficient Address."

### **Correspondence re: Brownell, Truman and Harry Dexter White, 1953**

Boxes 1-4 Unacknowledged. Unarranged.

Box 1 thru 4 Unarranged. No indication of acknowledgement.

### **Christmas Greetings, 1959**

Boxes 1-31        Most items are greeting cards with some letters. Some cards have notations of favorable comment on President's Goodwill Tour. Unarranged. Items are loose in boxes.

### **Christmas Greetings, 1960**

Boxes 1-12        Greeting cards and letters usually banded in small bunches with note attached indicating number of cards in each bunch and categorized as "adult," "children," "personal," etc. No other arrangement.

### **Correspondence re: Civil Rights, Bill to Establish a Commission**

Box 1              July – Sept. 1959. Unacknowledged. One folder.

### **Requests for a Special Session of Congress, 1958**

Box 1-12          The bulk of this material consists of news clippings that were printed in newspapers as advertisements in September, 1958. These clippings were sent to the White House by individuals and are in the form of a letter to the president protesting U.S.-China policy and asking that he put the issue before Congress by calling Congress into special session. The clippings were apparently sponsored by James P. Warburg. Bunches often have a note attached indicating number. Some notes indicate "counted on report." No other arrangement.

Box 13-15        These are news clippings similar to the above, but more widely critical of U.S. foreign policy and asking that President consult with Senate Foreign Relations Committee to shape proposals to be laid before Congress at earliest opportunity. Printed in Nov. 1958, clippings were apparently sponsored by James P. Warburg. Bunches often have a note attached indicating number. Some notes indicate "counted on report." No other arrangement.

**Correspondence re: Removal of Edward J. Corsi**
