- 3. Papers relating to investigations of individuals or to appointments and personnel matters.
- 4. Papers containing statements made by or to the donor in confidence unless in the judgment of the Director of the Dwight D. Eisenhower Library the reason for the confidentiality no longer exists.
- 5. All other papers which contain information or statements that might be used to injure, harass, or damage any living person.

SCOPE AND CONTENT NOTE

The papers of Oveta Culp Hobby relating to her 1952 political campaign materials and as first Secretary of the Department of Health, Education, and Welfare are divided into eight series.

The first series consists of press releases, newsletters, speeches, clippings, editorials, correspondence, campaign booklets, tear sheets and political sections of the Houston Post and other Texas newspapers, a scrapbook, memoranda, and other materials concerning General Eisenhower's 1952 presidential campaign and Mrs. Hobby's participation in it through the "Democrats for Eisenhower" and "Citizens for Eisenhower" organizations. This series is arranged alphabetically by title of folder, with the series is arranged alphabetically by title of folder, with the Houston Post tear sheets arranged chronologically at the end.

The second series consists of the personal files of Oveta Culp Hobby for the Period 1953 through July, 1955. It is primarily personal correspondence but also includes information relating to the following groups: Republican National Committee, National Federation of Republican Women, the New York University Hall of Fame, and the Southern Newspaper Publisher's Association. There is a reading file for the period, 1953-55. Other material associated with the correspondence, such as memoranda, clippings, scripts (one for a Helen Keller documentary), news releases, and greeting cards, is also included. Most of the photographs (136) were transferred to the photo collection. The subject content is both personal (acknowledgments of letters, gifts, engagements and letters concerning Mrs. Hobby's resignation from HEW) and political (information regarding various Republican clubs and, particularly, women in politics). Arrangement in this series is alphabetical by either subject or individual of group corresponding. Within the reading file the arrangement is chronological.

The third series consists of Mrs. Hobby's files as Secretary of Health, Education and Welfare, 1953-55. It is divided into several subseries according to the office or agency concerned (Department, Secretary-Immediate Office, Assistant Secretary for Program Analysis, Assistant Secretary for Federal-State Relations, Special Institutions, Departmental Council, Food and Drug Administration, Office of Education, Office of Vocational Rehabilitation, Public Health Service, and Social Security Administration) and whether the correspondence was with other government departments, agencies, or commissions or with non-government groups or individuals. There is also a subseries of materials from the Harlan L.P. Wendell files, probably background information for speeches. Included are copies of official correspondence, articles, editorials, budget estimates, printed copies of acts of Congress and the Congressional Record, newsletters and press releases, memos, reports on legislation, delegations of authority, messages from the Secretary, personnel records, agenda and other materials related to the White House Conference on Education (1954-55), invitations accepted and declined, etc.

Subject matter in this series corresponds to the agency, office or commission concerned in the subseries. Some of the major topics are: administration and appropriations, reorganization, aging, migratory labor, Freedmen's and St. Elizabeth's Hospitals, Gallaudet College and Howard University, problems handled by the Food and Drug Administration, education, vocational rehabilitation, air pollution, health statistics and advisory councils, hospitals, water resources,

the Salk Vaccine, Social Security, children and youth, various charities and foundations. Arrangement within each of the subseries mentioned above is alphabetical according to folder title.

The fourth series consists of a 3x5 index cards of speeches, testimony, and press conferences arranged in two alphabetical sequences, one filing by organization, the other by subject. Each entry gives the occasion, date, place and general topic of a particular speech testimony, or press conference.

The fifth series is a speech file containing notes, correspondence, background information, drafts, reading copies and press releases related to Mrs. Hobby's speeches, 1952-55, with the greater part concerning facets of Mrs. Hobby's role as Secretary of HEW. These speeches are arranged in three subseries: (1) a chronological file of all speeches and related materials; (2) a chronological file of speeches, other copies of which are found in the first subseries; and (3) speeches, organized by subject, which were formerly bound into books for 1953 and 1954, and chronological speeches for 1955 which were also bound ordinally.

The sixth series deals with press conferences. It consists mainly of anticipated questions and answers made up in preparation for specific press conferences, although there are also drafts of statements to be made, press releases, clippings and related correspondence included. One ring notebook (now in folders) contained transcripts of six press conferences. Important subjects covered are education, the Salk Vaccine, and Social Security, though there are questions covering the whole field of health, education and welfare. The arrangement here is chronological except in cases where a binder covering a long period of time was separated into several folders, causing some overlapping.

The seventh series covers the activities of the HEW Department before various Congressional Committees. It is mainly information gathered in preparation for appearances: copies of bills, statistics, charts, texts of statements, and some correspondence and memos. Some of the committees for which testimony was prepared are: both Senate and House Appropriations Committees, House Interstate and Foreign Commerce Committee, Senate Judiciary Committee investigating Juvenile Delinquency, House Committee on Education and Labor, Senate Committee on Labor and Public Welfare, and Senate Committee on Finance. Subject content is approximately the same as in the Press conferences. This series is divided into two subseries: (1) folders containing information related to particular appearances, arranged chronologically, (2) background books, progress reports, fact sheets etc. for general information purposes, also arranged chronologically by date of compilation or issuance.

The final series consists of approximately 140 scrapbooks containing newspaper clippings dealing with Mrs. Hobby's official and unofficial activities. Most of the scrapbooks cover the period 1953-55, although some date from 1941 and the latest is dated 1960. The clippings were taken by a clipping service from a large number of U.S. newspapers, so there is considerable duplication of subject content and articles. Most actions, statements or appearances of Mrs. Hobby are covered, some of the most notable being her affiliation with the WACs, her appointment to the Cabinet, actions as Secretary of HEW and eventual resignation, and the Salk Vaccine controversy. There are also many articles dealing with her personal charm and abilities.

These scrapbooks are placed in archives boxes and arranged chronologically, with the exception of the last three boxes which make up a subseries. The arrangement within this subseries is chronological; where there is overlapping of dates, a scrapbook is filed under the first date appearing.

Mrs. Oveta Culp Hobby was born January 19, 1905 in Killeen, Texas. She served as Parliamentarian for the Texas House of Representatives from 1926 to 1931 with incomplete terms in 1939 and 1941. In 1931 she married William P. Hobby, a former Governor of Texas. In the same year she joined the Houston Post as research editor, where she serve successively as literary editor, assistant editor, vice-president, executive vice-president, editor, publisher, and president (1955--). She served as chief of the Women's Interest Section of the War Department Bureau of Public Relations, 1941-42, was appointed director of the Women's Auxiliary Army Corps in 1942, then was commissioned as a Colonel, A. U. S., and severed as director of the WACs from 1943-45. She was Federal Security Administrator in 1953 until her appointment to cabinet status as Secretary of Health, Education and Welfare, 1953-55. She has served on numerous government and charitable committees and has written a parliamentary law textbook, and a syndicated column by the same title.
