Introduction

The National Cancer Institute's Behavioral Research Program (BRP) within the Division of Cancer Control and Population Sciences seeks to recruit a Cancer Research Training Award (CRTA) Fellow. BRP is pleased to invite applications from qualified candidates for this fellowship position in the Tobacco Control Research Branch. This full-time position is based in Rockville, Maryland and provides outstanding opportunities for training and professional development in behavioral medicine and tobacco control research. CRTA Fellows interact daily with researchers in public health, behavioral medicine, cancer prevention; and various extramural scientists at NCI and other Institutes and Centers of the National Institutes of Health.

Position Description

The CRTA Fellow will function as a member of TCRB and work directly with scientists on projects related to the TCRB mission. Areas of research include international tobacco control, state and community tobacco control policy and media interventions, and tobacco industry document research. Day-to-day activities might include conducting literature reviews; performing data analyses and preparing scientific manuscripts; aiding in the development of funding initiatives; analyzing the research portfolio; participating in staff meetings; and attending lectures or other training opportunities sponsored by the National Institutes of Health. Additionally, the Fellow may have opportunities to initiate and develop his or her own projects, and may have the opportunity to travel for NCI to national conferences, such as the Society for Research on Nicotine and Tobacco, Society of Behavioral Medicine, the American Psychological Association, or the American Public Health Association. The fellow will also have opportunities to work on projects in other branches of the Behavioral Research Program.

Qualifications

- MPH, PhD, or equivalent degree in public health, health education, epidemiology, health behavior, health communication, or related discipline.
- A strong interest in tobacco control and behavioral science research.
- Experience conducting research or serving as a research assistant on a scientific project
- > Data management skills (proficiency with EXCEL and statistical software packages is preferred)
- Superior academic achievement, typically of cumulative 3.5 GPA or higher
- Excellent organizational, planning, writing, and project management skills
- Excellent interpersonal skills
- The ability to work independently and on research teams

The stipend range for the initial appointment of a doctoral degree CRTA Fellow is \$45,000 - \$71,000, based on years of relevant postdoctoral research experience.
