# FICEMS Overview

- Created by Congress in 2005
- Representation from 10 different Federal agencies and an appointed State EMS Director
- Two or three in-person meetings annually
  - Teleconferences as needed
- Technical Working Group
  - Meet monthly via teleconference
  - Subcommittees meet regularly
- Staff support by NHTSA

# Statutory Authority

- Created in 2005 by Congress in SAFETEA-LU Legislation (42 U.S.C. § 300d-4) to:
  - Ensure coordination among Federal agencies involved with State, local, tribal or regional EMS and 9-1-1 systems
  - Identify State, local, tribal and regional EMS and 9-1-1 needs
  - Recommend new or expanded programs, including grant programs, for improving EMS and implementing improved EMS communications technologies, including wireless 9-1-1
  - Identify ways to streamline the process through which Federal agencies support EMS

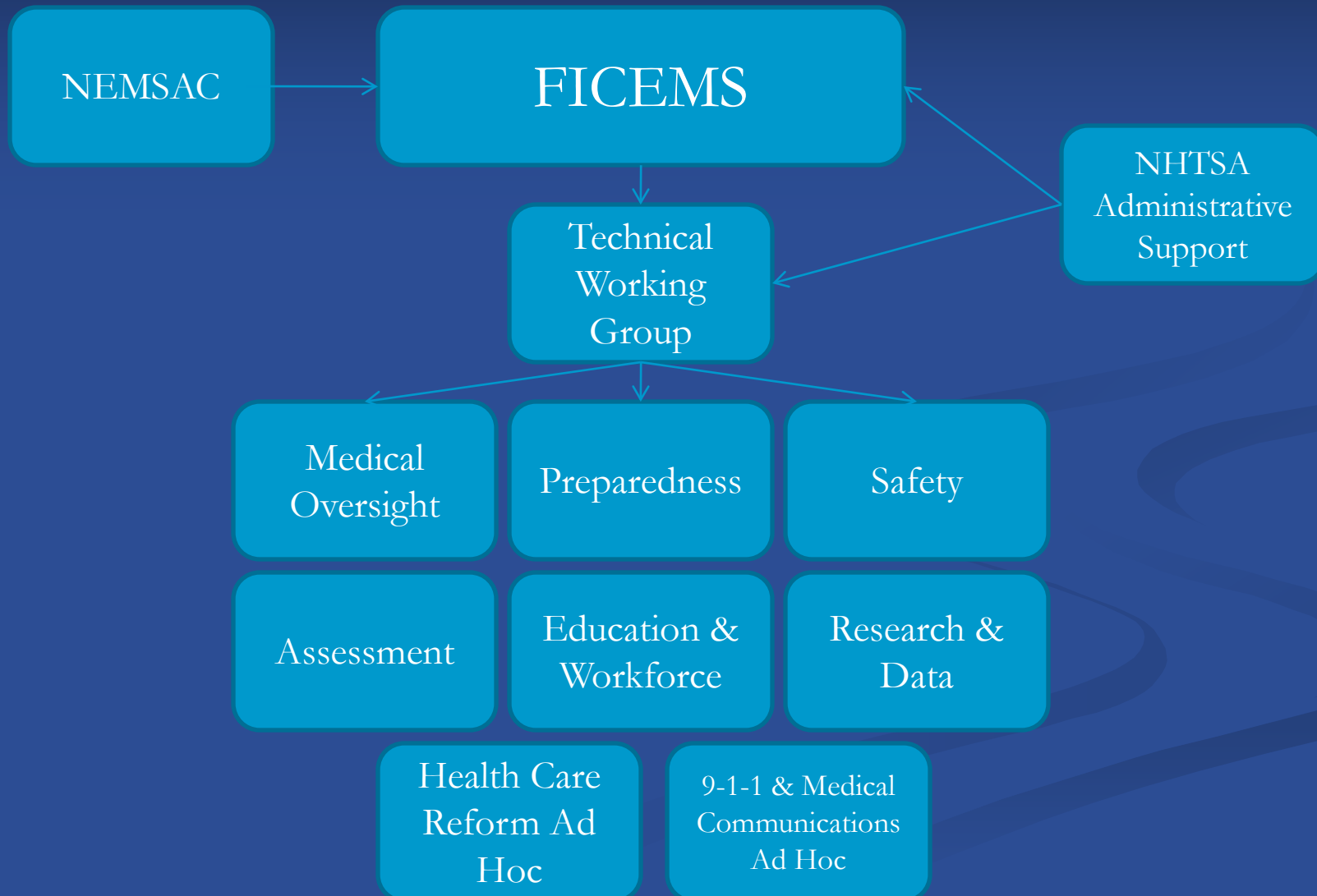
