- d. **[Add]** The Vice Chief of Staff of the Army directed (see reference m) all Army units to be 95% compliant on H1N1 immunization by 15 March 2010 and 100% compliant by 1 April 2010. As of 15 March 2010, the Active Army is at 91% compliance, the National Guard is at 57% compliance, and the Reserve is at 52% compliance. MEDCOM is at 97%. MEDCOM is in a unique position to assist all three components (COMPO) in achieving the Department of the Army standard to enhance force readiness.
