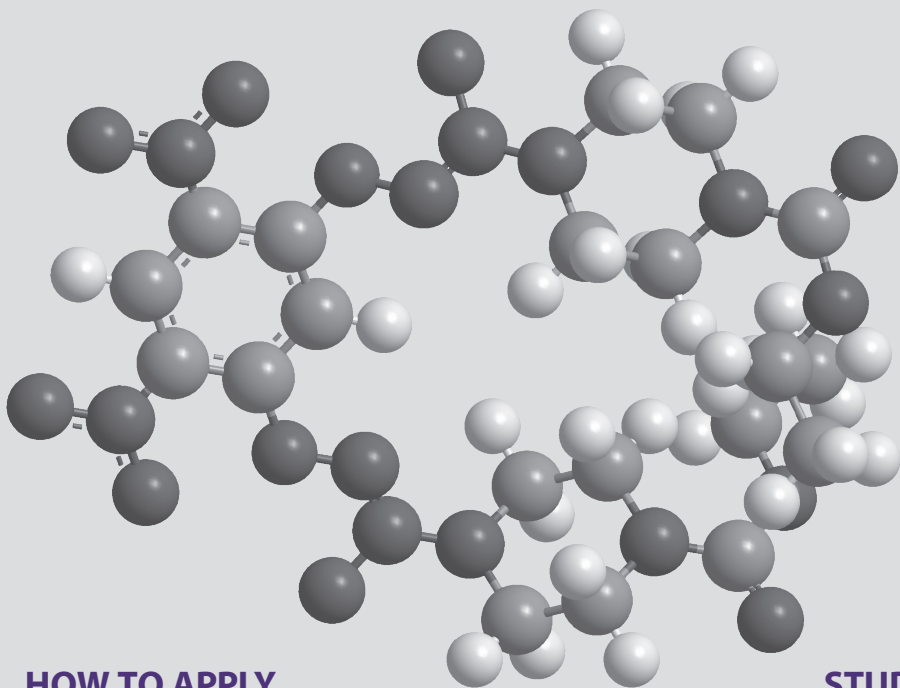

Summer Internship Program



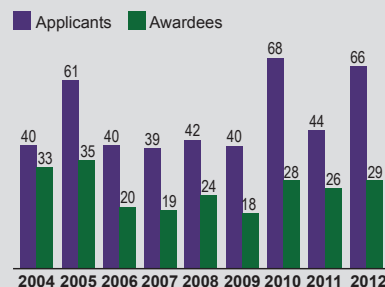
We are pleased to announce the **tenth Cancer Research Interns (CRI) Summer Internship Program**, sponsored by the Center for Cancer Research's (CCR's), Office of Training and Education. The focus of this program is to increase diversity. A Selection Panel of NCI scientists and administrators will review the application packages and interview prospective fellows with a GPA of 3.0 or higher, from groups under-represented in biomedical science, or disadvantaged backgrounds (with family income at/below the levels published in the *Federal Register*, Volume 77 (74), April 17, 2012 - page 22790 – see chart).

HOW TO APPLY

The complete application package has four components:

- On-line application** — www.training.nih.gov
November 15, 2012, to January 15, 2013 (new closing date)
Two references are required—both should be written by practicing scientists who know you personally and can speak to your ability to train in a biomedical research laboratory.
- Statement of Interest** (no more than one typewritten page) should be sent to vb55k@nih.gov with:
 - Name/school/major/graduation date
 - Career objective
 - Identification of under-represented group
 - Specific cancer-related interests
 - Short essay: Describe what you will bring to the program and why this training will make a difference in your academic trajectory.
 - Skills, including computer skills

STUDENT ELIGIBILITY

Applicants must be:

- In good standing, with a GPA of 3.0 or higher.
Official transcript required before training start date.
- U.S. citizens or permanent residents
- 18 years of age or older
- Students with cancer-related research interests
- From under-represented groups and/or financially disadvantaged backgrounds*

*The following groups are considered under-represented in biomedical science: African Americans/Black Americans, Hispanic/Latino Americans, Native Americans, Alaska Natives, and non-Asian Pacific Islanders

OTHER PROGRAM NOTES

Prospective CRI fellows will be interviewed by the Selection Panel and notified of their acceptance into the Program in early March (2013).
