Together, the CIO-SP3 GWACs are designed to support the Federal Enterprise Architecture, the Federal Health Architecture and the Department of Defense Enterprise Architecture, providing a full range of information technology services and solutions to the Federal Government.

#### PREPARE FOR eVIP EXPANSION

The NIH is currently preparing to expand the Electronic Vendor Invoicing Program (eVIP) for **view-only** capabilities to a limited number of vendors in FY12. eVIP is NIH's electronic invoicing solution, enabled by Oracle iSupplier, designed to provide a shared, real-time view of payment status and vendor information for OFM, ICs, and vendors.

The goal of the program is to eventually expand participation to the entire NIH vendor community. This expansion will have several impacts on the way the NIH community communicates with vendors. See below for details.

#### View Only - FY12/13

 The NIH will first invite six vendors into a view-only capability in iSupplier this summer. After registering for eVIP, vendors will have the ability to view the status of open orders, funding, invoices, and payments. A broader deployment for view-only to additional vendors will be planned for FY13.

On May 10, 2012, Mary Armstead, NITAAC Program Director, received an award for Acquisition Excellence from the AFCEA Bethesda Chapter at a ceremony celebrating their Government-Wide Initiatives Excellence Awards 2012. These prestigious awards recognize individuals or groups whose contributions in Information Technology (IT) have significance beyond their organization. Nominated by both Lockheed Martin and the NITAAC Program, Ms. Armstead was cited for achievements that advance business and citizen interaction, leading to improved effectiveness, cost-savings and leadership that meet national priorities and serve as a model of excellence government-wide.

#### GSA SMARTPAY WEBSITE: A SOURCE OF USEFUL INFORMATION

he NIH purchase cards are provided under what is known as the GSA SmartPay 2 contract. The General Service Administration (GSA) has a SmartPay website at www.smartpay.gsa.gov that contains a wealth of information. Did you know that the GSA SmartPay The GSA SmartPay website has other useful Program was established in 1998 and serves more than 350 federal agencies and organizations? In FY 2010, approximately \$98.9 million in transactions were made using GSA SmartPay charge cards (purchase, travel, fleet and integrated), resulting in transaction volume of \$30.2 billion and creating \$325.9 million in refunds for cardholders and their respective agencies.

One of the major responsibilities of the GSA SmartPay Program is to manage a set of master contracts through which federal agencies like NIH can issue a task order to obtain charge cards for employees which help to accomplish the agency or organization's mission. Agencies issue a task order under these master contracts, and award to one of the GSA SmartPay 2 contractor banks (JP Morgan who NIH is currently using, US Bank or Citibank). Participating in the GSA SmartPay2 program is beneficial to federal agencies because

each agency can maximize its ability to capture government sales, program statistics, transactions and Cardholder data. and also receive GSA SmartPay Program Refunds from the banks.

information for purchase cardholders, CAOs and IC Purchase Card Coordinators. There are answers to commonly asked questions, information on taxes, dispute forms, protecting one's card from fraud and abuse, SmartPay Bulletins about issues that impact the program, and also online GSA SmartPay training. This online training can be used to supplement the required training that cardholders and CAOs take at NIH. Other links on the website also allow users to access important policies and regulations, including: OMB Circular No. A-123 Appendix B; Federal Acquisition Regulations (FAR); Federal Travel Regulations; Per Diem Rates; and Public Law. #### SMALL BUSINESS GOALS BY THE NUMBERS

he following illustrates National Institute of as a whole in achieving all socio-economic goals for FY 12.

With less than four months remaining in Fiscal Year 2012, the National Institutes of Health (NIH) continues to exceed their small business goals in all but two categories.

As of May 18, NIH has awarded over \$457M to small business. Total small business awards by the Department total \$1.4B.

NIH continues to struggle with Hubzone and Service-Disabled Veteran-Owned Small Business (SDVOSB) goals. At the time of this writing, less than one percent of all NIH contracts went to

Hubzone firms. NIH's goal for contracts awarded Health's (NIH) progress versus the Department to Hubzone is 3%, or \$127,020,310. To keep pace with the Hubzone and SDVOSB goals, NIH would need to award \$37,313,409 to each socioeconomic groups by this time in the FY; currently only \$17,385,527 has been awarded to Hubzone firms, and \$11,102,307 to SDVOSB.

> We encourage all acquisitions professionals to contact the NIH Small Business Office for assistance in identifying small businesses, especially Hubzone and SDVOSB capable of meeting their procurement requirements.

The following results are from October 1, 2011 to May 18, 2012. Agency wide, HHS reported 18.66% of total acquisition dollars were awarded to small business.

n an effort to support the requirement for DCIS FPDS-NG Data Verification and Validation (DCIS V&V), the Contracts Data Management Program (CDMP) in the Office of Acquisition and Logistics Management (OALM) will offer training to ensure that all acquisition staff involved are in compliance with the Office of Federal Procurement Policy (OFPP) March 9, 2007 Memorandum Federal Procurement Data Verification and Validation http://www.whitehouse.gov/sites/default/files/ omb/assets/omb/procurement/pro\_data/ fpds\_030907.pdf

requiring accurate and timely input of contract information.

Each training session will include the following:

New Reporting Requirements Including TAS Code Requirements;

Top 12 FPDS-NG "Critical Field" errors; DCIS Version 1.4 changes

Each training session will be customized to support the needs of the individual Office of Acquisition or Delegated Acquisition Office. As part of the training, the CDMP trainer will cover all problem

areas and fields identified in a sample review by HHS. In order to facilitate this training, your office must provide the training location and ensure that it is equipped with a computer and the appropriate Internet access to allow the live entry of DCIS data. Additionally, the live data entry portion of the training session will require that official actions be brought to the training session.
