DoD Summer Educational Opportunity for HBCU/MI Students at USAMRMC

The DoD in collaboration with United Negro College Fund, Special Programs Corporation (UNCF-SP) and the USAMRMC have identified 4 summer intern positions at the U.S. Army Medical Research Institute for Infectious Diseases (USAMRID) for highly credentialed students from our nation's HBCU/MI. The four undergraduates are majoring in various medical research fields of study, maintain a G.P.A. of 3.5 or higher, and express a sincere desire to enhance their academics by working at a premier Department of Army Medical Research Laboratory, such as USAMRID. During the 7 week internship (June through August), these students, under the guidance and supervision of their assigned mentors will perform meaningful medical research duties that will culminate in the submission of a graded assignment.

The USAMRMC Office of Small Business Programs has received the unwavering endorsement of this program from MG. Schoomaker, the Commander of USAMRIID (COL George Korch) and key representatives from his staff that include Dr. Peter Hobart, SGM Edwin Lewis and Ms. Jennifer Merriman, to name a few. The Command's participation in this unique program is significant and a first for the USAMRMC. It also complies with the Presidential Executive Order which encourages federal agencies to establish and strengthen strategic partnerships with HBCU/ MI. The students are from Howard University, Bowie State University, Alcorn State University and Elizabeth City State University. We will continue to explore future opportunities for HBCU/MI undergraduate and graduate students to work as interns in USAMRMC Subordinate Laboratories and other areas.
