#### Notes

- **Time referent:** The Visit Survey asks respondents about experiences during their child's most recent visit with a provider, as opposed to all of their child's visits with that provider in the last 12 months. However, most questions about access to care refer to experiences over the last 12 months.
- References to "this provider" rather than "this doctor:" This survey uses "this provider" to refer to the individual specifically named in Question 1. A "provider" could be a doctor, nurse practitioner, physician assistant, or other individual who provides clinical care. Survey users may change "provider" to "doctor" throughout the questionnaire. - Supplemental items: CAHPS supplemental items for this survey are currently in development. In the meantime, users can adapt some supplemental items developed for the 12-Month Survey that are available in the Clinician & Group Surveys and Instructions

- Maximize readability by using two columns, serif fonts for the questions, and ample white space.
- Number the pages of your document, but remove the headers and footers inserted to help sponsors and vendors distinguish among questionnaire versions.


