1. INTRODUCTION

The Agricultural Health Study (AHS) is a collaborative effort involving the National Cancer Institute (NCI), the National Institute of Environmental Health Sciences (NIEHS), and the U.S. Environmental Protection Agency (EPA). The goals are to investigate the effects of environmental, occupational, dietary, and genetic factors on the health of the agricultural population. This study is providing information that agricultural workers can use in making decisions about their health and the health of their families.

The AHS has four major components:

- 1. The main prospective cohort study of cancer and noncancer outcomes that includes:
 - a. Linkage with cancer registries and vital statistics registries;
 - b. Ongoing data collection (i.e., telephone interview, food frequency questionnaire, and cheek cell collection (buccal cells));
- 2. Cross-sectional studies that collect (a) questionnaire data, (b) functional measures, (c) biomarkers, and (d) geographic information system (GIS) data;
- 3. Nested case-control studies; and
- 4. Exposure assessment and validation studies.

The AHS cohort includes 89,656 private pesticide applicators, spouses of private applicators, and commercial pesticide applicators recruited within Iowa and North Carolina (Table 1-1. Composition of Cohort). Data for the main cohort study have been collected in phases at approximately five year intervals. Phase I, initial cohort recruitment, began in December 1993 and concluded in 1997. Phase II follow up began in 1999 and concluded for private applicators and spouses in 2003. Phase II follow up of commercial applicators started in October 2003 and concluded in October 2005. The Phase III follow up began in November 2005 and concluded in February 2010.

This study explores potential causes of cancer and other diseases among farmers and their families and among commercial pesticide applicators. Current medical research suggests that, while agricultural workers are generally healthier than the general United States population, they may have higher rates of some cancers, including leukemia, myeloma, non-Hodgkin's lymphoma, and cancers of the lip, stomach, skin, brain, and prostate. Other conditions, such as asthma, neurologic diseases, and adverse reproductive outcomes may also be related to agricultural exposures. The Agricultural Health Study is designed to identify occupational, lifestyle, and genetic factors that may affect the rate of diseases in farming populations.

Iowa and North Carolina were selected for this study based on a nationwide competition. Both states have strong agricultural sectors with diverse production methods, commodities, and products. Information we learn from these two states will be helpful to farmers throughout the United States and other countries using modern agricultural technologies.

Phase I data collection involved administration of questionnaires to pesticide applicators and spouses of private pesticide applicators (i.e., spouses of farmers) to obtain information on pesticide use, other agricultural exposures, work practices that modify exposures, and other activities that may affect either exposure or disease risks (e.g., diet, exercise, alcohol consumption, medical conditions, family history of cancer, other occupations, and smoking history).

Phase II data collection involved administration of a computer-assisted telephone interview (CATI) to cohort members approximately 5 years after their initial enrollment. Following completion of the interview, participants were invited to participate in a collection of buccal (cheek) cells and asked to complete a Diet History Questionnaire. Those who agreed to the buccal cell collection were mailed a kit containing mouthwash, a collection cup, an informed consent form, and a preaddressed, postage-paid mailing envelope. Those who agreed to complete the Diet History Questionnaire were sent a questionnaire and a preaddressed, postage-paid mailing envelope.

Phase III data collection involved administration of a computer-assisted telephone interview (CATI) to cohort members approximately 10 years after their initial enrollment. Additionally, individuals with new diagnoses of specific cancers were invited to participate in a collection of buccal (cheek) cells. Those who agreed to the buccal cell collection were mailed a kit containing mouthwash, a collection cup, an informed consent form, and a preaddressed, postage-paid mailing envelope. Details on the buccal

collection and laboratory procedures and the related Buccal Receipt File are described in the. *Agricultural Health Study Demographic, Registry, and Biospecimen Files Users Manual.*

Cohort members were tracked passively through state vital statistics offices and the National Death Index (NDI) to determine vital status and, in the case of deceased persons, cause of death. They were also tracked through the Iowa and North Carolina cancer registries in order to record all malignant cancers in the cohort that were reported to the registries. Addresses for individuals not known to be dead and not contacted in the previous year were requested from the Internal Revenue Service. This was done to verify that they were alive and to determine whether they had moved out of Iowa and North Carolina so that person years of follow up could be determined.

This manual describes the Phase III data files and provides the basic information that an analyst needs to use them. It includes a brief description of the data collection and editing procedures and usage notes to guide the analyst. Detailed codebooks describing each of the variables and the meanings of the recorded responses are available to qualified researchers. The codebooks also contain frequency distributions for each of the variables. Copies of the questionnaires completed by the participants are available on the Internet at http://aghealth.nci.nih.gov/questionnaires.html. 2. DATA COLLECTION PROCEDURES

2.1 Eligibility

Farmers and commercial applicators who had enrolled in Phase I of the AHS by completing the Phase I Enrollment Questionnaire and had either completed another Phase I questionnaire, participated in any other Phase I or Phase II data collection activity, or had a spouse complete the Phase I Spouse Questionnaire were eligible for the Phase III interviews whether or not they still resided on a farm and whether or not they still participated in agricultural activities. All spouses of private applicators who enrolled during Phase I by completing the Spouse Questionnaire were eligible. Participation in each of the data collection activities was voluntary.

A few cohort members were excluded from the Phase III interviewing and other active data collection activities. These included those who died prior to being contacted for an interview, those who felt too ill to participate, those unable to communicate over the phone, those who requested that they no longer be contacted by the study, those who participated in pilot administrations of the CATI instrument, and those who could not be located. The last group included people for whom no phone number could be found, as well as those with unpublished numbers or blocked lines. No proxy interviews were conducted.

Some individuals died after they were interviewed. Therefore, a researcher should not assume that someone whose ID appears in the Mortality File was excluded from interviewing. The cancer status and vital status of people excluded from the interviews were still tracked passively using the Iowa, North Carolina, and national databases available to the study.

2.2 Main Data Collection

The primary data collection activity during Phase III of the AHS was the administration of CATI interviews. The interviews were conducted between November 2005 and February 2010.

2.2.1 CATI Interviews

The Phase III interviews used the same questionnaire for all respondents, although there was some tailoring of which questions were asked based on gender. The CATI interviews, which were written in Blaise, were constructed in a modular fashion. The questionnaire contained the following major sections:

- Section 1: Introduction and Update of Residential Information
- Section 2. Farming Operations
- Section 3. General Pesticide Usage
- Section 4. Pesticide Names and Frequency of Use¹
- Section 5. Application Methods and Personal Protective Equipment
 (PPE) Use for Most Frequently Applied Pesticides
- Section 6. High Pesticide Exposure Events
- Section 7. Non-Farm Occupation Information
- Section 8. Exposures And Important Confounders
- Section 9. Physical Activity
- Section 10. Sun Exposure
- Section 11. Other Agricultural Exposures
- Section 12. Cardiovascular Conditions
- Section 13. Respiratory Conditions
- Section 14. Diabetes
- Section 15. Thyroid Conditions
- Section 16. Neurological Conditions
- Section 17. Allergic Conditions
- Section 18. Infectious Conditions
- Section 19. Autoimmune Conditions
- Section 20. Eye and Ear Conditions
- Section 21. Head Injury
- Section 22. Arthritis and Osteoporosis
- Section 23. Respiratory Symptoms
- Section 24. Neurological Symptoms
- Section 25. Pesticide Conditions
- Section 26. Family History of Disease
- Section 27. Prostate Health Care
- Section 28. Women's Reproductive Health

¹ Variables from Section 4 are found in the Supplemental Pesticide File. Note that the Supplemental Pesticide File has a separate record for each unique combination of respondent ID, pesticide name, and application target (animal, crop, or non-crop).

The first section verified the identity and demographic information of the respondent and asked about the source of drinking water, with some follow up questions if the source was a private well or spring. The second section asked if the respondent had been actively engaged in farming in any year since the year of enrollment and, if so, what was the most recent year. This section also asked the respondent to list crops and animals raised on his or her farm and gathered information on key farming activities.

Section 3 asked if the respondent was currently a certified (licensed) pesticide applicator and whether he or she personally mixed, loaded, or applied pesticides. If so, the interviewer asked how many years since the last interview the respondent mixed, loaded, or applied pesticides and the average number of days per year in which he or she did so.

Sections 4 through 6 asked for details about which pesticides were used and the respondent's usage of them. These sections were skipped if the person indicated in Section 3 that he or she did not personally mix, load or apply pesticides. The remaining sections asked about life style factors that could influence a person's health, collected data on a number of specific diseases and health conditions, and asked about family history of disease.

2.2.2 Pesticide Use Sections

Section 4 was designed to collect a comprehensive list of pesticides used by the respondent. This was done by asking the respondent to name each pesticide he or she had personally used on crops. After the list of pesticides used on crops was complete, the interviewer asked the respondent to name the pesticides personally applied to animals or in animal confinement areas. When the animal pesticide list was complete, the interviewer asked the respondent to name pesticides personally applied for other types of applications, such as pastures, fence rows, roadsides, around buildings, grain bins, for rodent control or for applications not already mentioned that were not for home and garden use. The interviewer then said, "I would like to ask about some other commonly used pesticides that you have not mentioned," and proceeded to ask individually about each "A-list pesticide" that the respondent used during Phase II of the study that he or she had not yet mentioned. Up to this point in the questionnaire, the interviewer was able to change a pesticide name or add or delete pesticides from the list if the respondent remembered something not mentioned earlier. Once the next question (Q4.5) was asked, the interviewer could not

change previous responses although he or she could create a comment with the relevant information so that a data editor could correct the file later. The questionnaire was programmed in this manner so that the data used to determine the most frequently used pesticide of each type, which was needed in Section 5 of the questionnaire, was not changed later in the questionnaire.

Question 4.5 was, "Are there any other pesticides that you have used that you have not mentioned, not including pesticides for home and garden use?" If the response was, "Yes," the interviewer then went on to collect the name of any such pesticide and whether it was used on crops, animals, or non-crops. When this question was asked, the interviewer could see a list of A-list pesticides that the respondent had reported using in Phase II that had not yet been reported in the current interview. If the respondent stopped naming pesticides without naming one or more of these previously named chemicals, the interviewer prompted the respondent with the pesticide's name.²

Questions 4.6 (variable P3_YRSLIFE) and 4.7 (variable P3_DAYSYRLIFE) were then asked for each of the chemicals named so far in the interview:

Note that although most farming-related items in the questionnaire ask about the person's experience since the last interview; Question 4.6 asks, "For how many years *over your lifetime* have you personally mixed, loaded, handled, or applied this pesticide?" We have provided two different calculations for total number of lifetime days of use for each pesticide. One is the product of the responses to questions 4.6 and 4.7. We created the second variables to be parallel to the data calculation

² After this point in the questionnaire, if the respondent remembered using another pesticide or wanted to correct previously reported information, the interviewer was able to enter the information in a "parallel track" that captured the fact of the pesticide usage. The interviewer also set a flag with one of the values *DELETE, *CHANGE, or *ADD. These flags and comments entered by the interviewer were later reviewed by Data Management staff at the Coordinating Center.

performed for Phase II. For the second calculation, we multiply the number of days reported in question 4.7 by the number of years since the last interview, and add the result to the total number of usage days for the pesticide reported by the respondent in Phases 1 and 2. This is similar to what was done for the Phase II data set. For example, P3_HRB_A_RPT_LIFE_DAYS_1 is the Phase III reported life days for use of Atrazine based on the responses to Questions 4.6 and 4.7 while P3_HRB_A_LIFE_DAYS_1 is the sum of the days the respondent used Atrazine during each of the data collection Phases (Phase 1, Phase II and Phase III).

Section 5 of the questionnaire asks about the application methods the respondent used for handling pesticides since the last interview. Since the Phase II questionnaire responses showed relatively little variation in application methods and PPE use within a class of pesticides this set of questions was asked only once for the most intensively used pesticide indicated by the respondent in each of 6 categories:

- Herbicide to crop
- Insecticide to crop
- Fungicide to crop
- Insecticide to animal
- Pesticide for non crop applications
- Fumigants

Note that because the pesticides mentioned by the applicator in response to question 4.5 were not categorized into any of these 6 categories, they were not considered when determining the most frequently used pesticide. Although it is uncommon for someone to forget the most frequently used pesticide until this point in the questionnaire, it did happen on occasion.

3. DATA PROCESSING PROCEDURES

A major advantage of collecting data through computer assisted interviewing is that basic checks can be made on the data as it is entered, giving the interviewer fewer opportunities to make errors (impossible values are blocked) and to correct some types of errors immediately ("soft" range checks warn the interviewer of unusually high or low values). Another important advantage is that data files are available in electronic form as soon as the interview is complete.

The questionnaire contained a list of pesticides from which interviewers could select (see the questions labeled with the variable name "P3_PESTICIDE_VERBATIM": questions 4.1a, 4.1c, 4.2a, 4.2c, 4.3a, 4.3c, 4.5b, and 4.5e). If the respondent named a pesticide not on the list, it was keyed in by the interviewer. Westat staff developed a list mapping each verbatim pesticide name to a table of standard pesticide names. When a new verbatim name was encountered, it was sent to experts at NCI and NIEHS for review and was then either associated with an existing standard pesticide name or with a new name that was created to reflect the appearance of a new product not previously encountered during the study. Some verbatim names could not be associated with any known commercial pesticide and were associated with one of the following names as appropriate: unknown herbicide, unknown insecticide, unknown fumigant, unknown fungicide, or unknown pesticide.³

3.1 Data Cleaning

The field stations randomly selected five percent of the interviews and reviewed recordings of the interview and the corresponding questionnaire entries. In the rare instances in which problems were found, the field station staff sent a problem sheet describing the issue to the Coordinating Center for resolution.

During the interview, pesticide usage was reported for crops, animals or animal confinement areas, other non-crop or non-animal areas, and pesticides previously identified in phase II. Respondents were given the opportunity to make additions or corrections to what they had reported prior to gathering more specific information about each pesticide reported. An "incorrect pesticide" value was added to the

³ Note that the lists of pesticide names used in the questionnaire and the list associating verbatim pesticide names with standard pesticide names were based on those used in Phase II of the study. The revised and expanded verbatim-standard name association list was used in both the July 2010 release of the Phase II data files (release P2REL201007.00) and the Phase III data files.

high usage question series as well as the individual lifetime usage question. Data Management staff at the Coordinating Center reviewed a pesticide report that identified the pesticides recorded during the interview, any add, change or delete flags associated with the pesticides, comments inserted by the interviewer, and any values of "INCORRECT PESTICDE" that were used in the interview. Adjustments to the pesticide table were made as a result of this review and coding instructions relevant to the pesticide table. Updates were also possible as a result of problem sheets related to the interview that had been sent to the Coordinating Center by the field stations.

"INCORRECT PESTICIDE" responses were added to questions 4.6, 5.9, 5.17, 5.28, 5.29 and 5.31 to allow for deletion of pesticide names that were entered earlier in the interview.

- Q4.6) You mentioned that you have used **Pesticide_Verbatim Pst_Used_On_Txt**. For how many years over your lifetime have you personally mixed, loaded, handled, or applied this pesticide?

The Data Management staff also reviewed all "Other, specify" verbatim responses to determine when they could recoded to one of the existing response choices.

When there were a substantial number of similar responses to an "Other, specify" question, we created new codes reflecting these responses and recoded the responses accordingly. A full list of both the old and new codes is contained in Appendix C.

Data management staff at the Coordinating Center repeated both the hard range checks and embedded logics within the instrument. Any unusual values that had been detected by the soft range checks and approved by the field stations were verified. All verbatim responses and comments were reviewed. Any that seemed to need further information had requests sent to the field for clarification and/or adjustment.

Requests to change data, from comments, special codes, and after-the-fact requests, were reviewed and dealt with. Any new issues or discrepancies that arose because of the change request were sent for clarification to the relevant field station until all range checks and logics were resolved or accepted as correct.

3.2 Preparation of Analytic Files

The questionnaire responses from the Iowa and North Carolina field stations were combined into a file for private applicators (P3PrivateApplicator.sas7bdat) and a file with the same data structure. for spouses of private applicators (P3Spouse.sas7bdat).⁴ Because a respondent could name any number of pesticides in Section 4, we placed variables representing responses to question in this section in the applicator and spouse supplemental pesticide files, which are named P3PrivAppSuppPest.sas7bdat and P3SpouseSuppPest.sas7bdat, respectively. Note that the supplemental pesticide files have a separate record for each unique combination of respondent ID, pesticide name, and application target (animal, crop, non-crop, or other).

The remainder of this section discusses the following topics:

- Variable Naming Conventions
- Pesticide Exposure Flags
- Pesticide Exposure Algorithms
- Derived Variables
- Missing Value Codes

Each topic is discussed in a separate section below.

3.2.1 Variable Naming Conventions

To the extent possible, variable names were kept as similar to those used for the corresponding variables in Phase I and Phase II of the study. Almost all variables in the Phase III data sets begin with the prefix "P3" to distinguish them from Phase II variable names, which start with the prefixes "A2," "C2," and "S2" and the Phase I variable names, which started with "A," "C," or "S.". The exceptions are the variables PARTID (participant ID), which has the same name and meaning in all AHS data files, and the following pesticide-related variables that appear in both the Phase II and Phase III supplemental files with identical meanings:

- AIName1 Active ingredient name 1
- AIName2 Active ingredient name 2
- AIName3 Active ingredient name 3

3.2.2 Pesticide Exposure Flags

There are three sets of pesticide exposure flags in the Phase III data files:

- A-List and B-List Personal Use Indicator Variables;
- Phase III A-List List Lifetime Personal Use Indicator Flags; and
- Phase III Used on Farm Indicator Flags.

Each set of flags is described in a separate section below.

3.2.2.1 A-List and B-List Personal Use Indicator Variables

A personal use indicator variable was created for each of the 83 A-list and 40 B-list variables (see Appendix A and Appendix B). Core A-list variables are the 50 chemicals asked about in the Enrollment Questionnaire during Phase I. These were supplemented by 33 additional chemicals of high interest that were reported as being used during the Phase II interviews. B-list chemicals are those not on the A-list that were reported as being used by 300 or more applicators in Phase II. The core A-list variables have "_A_" in their variable names. The 33 additional A-list variables have "_AA_" in their variables have "_B_" in their variable names.

For example, P3_FUMIGANT_A_1 is the indicator for personal application of Methyl Bromide (PCCODE = 053201). The flags were set for each applicator based on the active ingredients in pesticides reported by the respondents. If the reported pesticide had the specific A-list or B-list chemical as one of its active ingredients,⁵ the indicator flag was set to either 0 or 1. If the respondent indicated that he or she personally mixed loaded or applied the pesticide for zero days, the indicator flag was set to 0. If the respondent reported a positive number of days of use for the pesticide or did not answer the days of per year question (see Section 3.2.3.3), the pesticide exposure indicator flag was set to 1. It the respondent stated that he or she applied a chemical zero days per year for some products and did not give us the number of days for another product containing the chemical, we treated the days per year information as missing and set the exposure indicator flag to 1. This logic is summarized in Table 3–1.

3.2.2.2 Phase III A-List List Lifetime Personal Use Indicator Flags

A set of lifetime personal indicator flags was created for the A-list variables. For example, P3_FUMIGANT_LY_A_1 is the lifetime indicator flag for personal use of Methyl Bromide during Phase

I, II or III. If the personal use indicator for the chemicals is true in Phase I, II or III for a participant, then the lifetime indicator for the specific pesticide is set to 1 (true); otherwise it is set to 0 (false). Note that these variables were created only for the 50 chemicals asked about in the Phase I questionnaires.

In the Phase I Enrollment Questionnaire applicators were asked about use of 22 chemicals including the number of years of use and the average number of days per year. They were also asked whether they had mixed, loaded, or applied 28 additional pesticides but were not asked about the amount of use. These 28 pesticides were, however, asked about in a take-home questionnaire which repeated the question about whether the applicator had mixed, loaded, or applied the chemical and also asked about years and days of use. The take-home questionnaire was completed by approximately 40 percent of the applicators. The Phase I A-list indicator used here is derived using both Enrollment Questionnaire and Take Home Questionnaire variables when available; for example, A_HERBICIDE_CD4/ P1_CD_INDS and A_EVER_HERBICIDE4/ P1_EVER_INDS). The logic used is parallel to that used in Phase II.

The variables P1_CD_INDS(I), P1_EVER_INDS(I), and ALIST_P1_INDS(I) are temporary arrays of indicators where "I" represents a specific pesticide. P1_CD_INDS(I) is the indicator for chemical I that was asked as part of the set of questions that that asked about years and days of use. P1_EVER_INDS(I) for chemical I that was asked by itself without the years and days questions. ALIST P1 INDS(I) is the derived indicator for chemical I.

3.2.2.3 Phase III Used on Farm Indicator Flags

In Phase II a separate "used on farm" variable was created to indicate that the respondent reported use of the pesticide, whether or not he or she personally used it. These sets of variables were named in a similar manner as the personal use indicator variables except that "RY" in the variable name was replaced with "UF". In Phase III the used on farm indicator variable is set to 1 if the respondent has reported a pesticide name with a specific A-list active ingredient, otherwise it is set to 0. While the used on farm variables and the personal use indicator variables in Phase II can and do differ, because of the structure of the Phase III questionnaires, the used on farm set of variables in Phase III have exactly the same value as the personal use indicator variables. The used on farm variables have never-the-less been kept for the sake of consistency with Phase II. Thus P3_FUMIGANT_UF_A_1 represents reported use

of Methyl Bromide (PCCODE=053201) in the Phase III in the supplemental file. The Phase III Used on Farm variables may be omitted from future data releases. For this reason when the analyst has a choice of methods for using this information, it would be better to use the corresponding personal use indicator variables such as P3_FUMIGANT_RY_A_1.

3.2.2.4 Pesticide with Unknown Active Ingredients:

Some of the pesticide names in the supplemental files have been assigned PC Code indicating an unknown pesticide or an unknown pesticide type:

3.2.3 **Pesticide Exposure Algorithms**

Exposure to pesticides during farming operations is not simply a matter of the amount of time a person is exposed to pesticides. A farmer spraying crops while riding in a tractor with an enclosed cab and an air filtration system is likely to receive a smaller effective dose of a pesticide per unit time than a farmer using a backpack sprayer to apply a pesticide to trees in an orchard. The intensity level of pesticide exposure is a function of pesticide handling procedures (i.e., mixing, loading, application of pesticides and repairing of equipment) and protective equipment used. Algorithms for estimating exposure intensity are documented in Dosemeci et al. (2002).

Dosemeci et al. (2002) includes two algorithms for estimating the intensity of exposure. The first algorithm is based on questions in the Enrollment Questionnaire and it what is now termed Version 1 of the algorithm. The second algorithm used responses from both the Enrollment Questionnaire and the private applicator and commercial applicator Take Home Questionnaires. Since only 40 percent of the applicators completed the Take Home Questionnaire, this version of the algorithm, which was called "Algorithm 2" in the Phase I documentation, has not been used in analysis and is no longer included in AHS analysis files.

A new version of the intensity algorithm was defined in 2007⁶. This version uses the results of a study of a subset of AHS applicators conducted by EPA that collected extensive biomarker data to calibrate the questionnaire responses⁷. This 'Version 2' of the algorithm should be used in future analyses of AHS data.

The basic concept of intensity adjusted days of exposure to a pesticide can be expressed as

Intensity Days = Total Application Days * Algorithm Intensity Score

The Algorithm Intensity Score is a function of application methods used and PPE used. The Algorithm Intensity Score calculation is different in Version 1 and Version 2 of the algorithm.

For Version 1 of the algorithm, a combined PPE factor, which is used with the Repair Score, was defined as the minimum of the PPE_Mix factor and the PPE_Apply factor. The Algorithm Intensity Score is the sum of the product of each score and its corresponding factor.

For Version 2, the Algorithm Intensity Scores for each application in the Phase II Supplemental File are calculated as:

Algorithm Intensity score = (Mix score + Apply score + Repair score) * Combined PPE Factor

Subjects with missing values for one or more of these four variables were assigned missing algorithm intensity scores. Subjects for whom the sum of the Mix Score, Apply Score, and Repair Score is zero will also be assigned missing algorithm intensity scores.

Mix scores, apply scores, and repair scores were created representing the pesticide-related activities of mixing pesticides, applying pesticides, and repairing equipment. For each of the six pesticide application categories (herbicide to crop, insecticide to crop, fungicide to crop, insecticide to animal, pesticide for non crop applications, and fumigants) respondents were asked what application methods were used for the most frequently used and next most frequently used pesticides. Respondents were also asked about their use of PPE when mixing, loading, or applying pesticides. Repair information was collected with question 5.39 (variable P3_REPAIRAPPLEQ):

The PPE factor was calculated using a formula which can be informally summarized as:

where each of the "use" variables has a value of 0 or 1. Note that PPE credit of 0.6 is given for use of protective gloves and 0.1 for use of each of the other kinds of PPE listed up to a maximum of 0.3 for the non-glove types of PPE.

Two PPE factors were calculated, one for mixing and one for applying. The minimum (i.e., more protective) of the two values was used for calculation of the Phase III intensity score. In other words, the combined PPE factor is the minimum of the PPE mix factor and the PPE apply factor

The calculation of the algorithm scores and related variables in the Phase III main applicator and spouse datasets and supplemental datasets was performed in a manner parallel to the logic used for the corresponding Phase II variables with adjustments made to reflect variations in the questionnaires. This section describes the derivation details of the following classes of derived variables:

- Phase III algorithm scores, including the mix scores, apply scores, repair scores and combined PPE factors.
- Intermediate Derived Variables
- Phase III Days per Year of Use.
- Phase III Reported Life Years.
- Phase III Reported Lifetime Days.

- Average Algorithm Intensity Score.

- Total hours of use since enrollment.
- Algorithm Adjusted Hours.
- A-List Lifetime Indicators.

3.2.3.1 Phase III Algorithm Scores

The PPE Mix Factor is used in the intensity adjusted algorithm scores to reduce the estimated exposure based on the amount of personal protective equipment used. The original values were set based on an analysis of the available literature. Version 2 of the PPE Mix Factor was created to reflect the knowledge gained from an in-depth study of a subset of Agricultural Health

Study applicators who allowed researchers to observe their pesticide handling practices and take a number of biological and environmental samples before and after pesticide operations.⁹

3.2.4 Derived Variables

Derived variables are variables created by combining or manipulating responses to items asked directly in the questionnaires. A number of types of derived variables are included in the data files:

- Conversion of arrays to indicator variables;
- Variables in supplemental files summarized in analysis files;
- Functional and chemical class flags;
- Conversion of multiple response lists to indicator variables;
- Added names of active ingredients corresponding to the PC Codes; and
- Created days per year and hours per year variables.

The derivation of each type is discussed in a separate section below.

3.2.4.1 Conversion of Multiple Response Lists to Indicator Variables

Questions with lists that allow the interviewer to mark all the responses given by a respondent have been converted from lists of variables each of which could take any of the response codes to indicator variables for each possible response. Each indicator variable has the value of 0 if the respondent did not name the item or 1 if he or she did mention it.

The data structures used for data collection during the interviews were effective for that purpose but are awkward to use for the purposes of data analysis. For instance, question 2.3, "Excluding gardens for personal use, what crops, including fruits and vegetables, were raised on your farm since [the year of the last interview]?" lists 42 crops and includes the interviewer instruction "CODE ALL THAT APPLY." The CATI instrument collected these responses in an array. The order of the entries in the array reflected the order in which the respondent named the crops. For analysis purposes, these responses were converted to a set of indicator variables with a separate variable for each crop (e.g., P3_CR_APPLES, P3_CR_ALFALFA, and P3_CR_BARLEY). Each of these variables was set to the value 1 if the respondent named the corresponding crop and left as missing if he or she did not name the crop.

One of the possible responses to this question was "Other, specify." When this response was received the name of the additional crop was recorded in the variable P3_OTHCROP. New indicator variables were created to reflect these responses as well. The full set of crop indicator variables is listed in Appendix C.

3.2.4.2 Variables in Supplemental Files Summarized in Analysis Files

The Private Applicator Supplemental Pesticide File and the Spouse Supplemental Pesticide File contain detailed information on the number of days and hours the respondent applied each pesticide to each crop, animal, or noncrop to which he or she applied it. For each pesticide on the A list, the number of application days and the intensity-adjusted application days have been summarized at the pesticide level and placed on the respondent's record on the main Private Applicator File or Spouse File. Key Phase I exposure variables have also been placed on the Phase III master Private Applicator File 10

For each of the types of pesticides that a person used, the interviewer asked the respondent "what application method did you use the most?" for the pesticide with the highest number of application days in that category. The interviewer also asked, "What application method did you use the second most?"

¹⁰ The years of use and days of use variables were not collected for Spouses in Phase I.

Information on use of personal protective equipment (PPE) was collected at the person level so that an adjusted exposure estimate could be made taking these practices into account. The adjustment was made by multiplying the total exposure in hours by an intensity score which was based on applicator behavior. The intensity algorithm used was comparable to that used during Phase I of the AHS (see M. Dosemici et al., 2002). An intensity score was calculated for each of the 83 chemicals on the A list when the data were available on the questionnaire. Since some of the chemicals on the list that were based on the Phase I questionnaire are no longer used, there was no exposure to them and thus no intensity scores were calculated for them. In Phase I, it was not possible to distinguish PPE used while mixing chemicals from that used in applying them. Both types of information were collected in Phase II and in Phase III. Phase III intensity scores use the separate data PPE data for mixing and applying chemicals and a combined PPE score when adjusting repair-related exposure estimates.

3.2.4.3 Functional and Chemical Class Flags

Two sets of related derived variables were also created and placed on the analysis files: chemical class flags and functional class flags. These are shown in Table 3–7 and Table 3–8. The chemical group flags have the same definitions as those on the Phase I data sets.

3.2.4.4 Added Names of Active Ingredients Corresponding to the PC Codes

A set of four variables on the Supplemental Pesticide Files provide the names of the chemicals represented by the PC codes. AIName1 corresponds to PCCode1, AIName2 corresponds to PCCode2, AIName3 corresponds to PCCode3, and AIName4 corresponds to PCCode4. For example, Pursuit Plus contains two chemicals, Imazaquin (PC Code 128848) and Pendimethalin (PC Code 108501), so the PCCode and AIName variables have the values shown in Table 3-8.

3.2.4.5 Created Days per Year and Hours per Year Variables

Each record in the Phase III Private Applicator and Spouse Files contains a set of days per year variables for each pesticide on the extended A list -- the list of 83 pesticides consisting of the 50 pesticides included in the Phase I questionnaire supplemented by 33 additional pesticides of high interest reported during Phase II. A corresponding set of 83 hours per year variables was also created.

The days per year variable for a specific respondent and specific pesticide was created by first determining the maximum number of days per year reported by the respondent for a pesticide for each application type (Crop/Animal/NonCrop). The days per year value for that pesticide for that person was calculated as the sum of these three maxima. That is, it was the sum of the maximum reported days per year over all crops for which that respondent used that pesticide, the maximum reported days per year over all animals for which that respondent used that pesticide, and the maximum reported days per year over all noncrops for which that respondent used that pesticide.

The hours per year variable for a specific respondent and specific pesticide was created by multiplying the reported days per year by the reported average hours per day for each reported instance of use of the pesticide and then summing these products over all reports across all application types.

3.2.4.6 Smoking Status and Pack Year Variables

Derived variables were created to represent each respondent's smoking status at the time of the Phase III interview and the number of pack years that he or she smoked.

3.2.5 Missing Value Codes

Missing character values are represented by blanks. Missing numeric values are set to ".D" if the respondent did not know the answer to a question and to ".R" if the respondent refused to answer a question. Inapplicable questions that were skipped because of respondent demographics or responses to previous questions are given the value ".S". All other missing values are set to the standard SAS missing value of ".".

3.2.6 Treatment of Differences among Versions of Modules

Approximately one month after data collection started with the Phase III CATI instrument, the AHS Executive Committee reviewed the data collected to that point and decided to make some minor changes to the questionnaire, which were implemented during the sixth week of interviewing. The changes are documented in the codebooks. Differences among the different versions of the questionnaire modules required a certain amount of recoding of the earlier versions in order to make the responses commensurate with those in the final versions of the modules. The major differences and how they were treated are described below.

In addition the entire Physical Activity Section (Section 9) was replaced. The Version 1 questions focused primarily on the frequency (in stated categories) of certain activities at work, as well as the average number of hours spent in strenuous activity at both work and leisure. Version 2 questions ask for a length of time spent for vigorous, moderate, walking and sitting activities. Only the Version 2 questions are included on the data file. The discontinued version is contained in Appendix D. See Section 9 of the annotated questionnaire for the version of the questions included in the data files.

3.6 Body Mass Index Estimates

Question 8.4 asked respondents for their height, which was record in two variables: one for the portion reported in feet (P3_HGTFT) and one for the portion reported in inches (P3_HGTIN). Question 8.5 asked respondents for their current weight in pounds (P3_WEIGHTNOW). The Phase III Body Mass Index variable (P3_BMI) was calculated by dividing the respondents reported weight by their height in inches and multiplying by 703.

Note that BMI estimates from earlier phases of the study are available in the Demographic File.

4. DATA FILE DESCRIPTIONS

The Phase III data consist of a set of related files which can be linked to each other and to the Phase I and II files by the study IDs of the respondents. The following files are part of the Phase III data:

- Private Applicator File
- Private Applicator Supplemental Pesticide File
- Spouse File
- Spouse Supplemental Pesticide File

Codebooks for each of these files that provide a detailed description of their contents are available for authorized researchers. Each of the Phase III files is discussed briefly in a separate section below.

4.1 Private Applicator File

The Private Applicator File contains the responses to the questions in the Phase III CATI interviews of private pesticide applicators. It contains 24,172 records. Of these; 15,760 are from Iowa farmers and 8,412 are from North Carolina farmers. It also contains a number of derived variables that will be of use to analysts. A number of these record administrative information. The administrative variables are summarized in Table 4-1.

Note that while most of the questions in the CATI questionnaire are directly represented in the file by a single variable, responses to Sections 4 and 5 of the questionnaire have been restructured to make them easier to use in analyses. In particular, indicator variables were created to reflect crops and animals to which pesticides were applied and to reflect which chemicals were used (see Section 3.2.2). Details about specific applications of pesticides have been placed in the Private Applicator Supplemental Pesticide File (see Section 4.2).

Indicator variables were created for each crop, animal, and noncrop; each A-list or B-list pesticide (see Appendix A, Appendix B, and the pesticide classes listed in Table 3–7 (Functional Classes) and Table 3–8 (Chemical Classes). These indicators have the value 1 if the respondent grew the crop or applied the pesticide and 0 if he or she did not do so. There is a separate indicator variable for each of the

crops named in the questionnaire. For example, the indicator variables for apples, alfalfa, and barley are P3_CR_APPLES, P3_CR_ALFALFA, and P3_CR_BARLEY, respectively.

It was not useful to create indicator variables for all of the thousands of pesticides named by the respondents. A pesticide was assigned an indicator variable if it was one of the 50 chemicals listed in the Phase I questionnaires (50 core A-list variables), if it was suspected of having adverse health effects (33 additional A-list variables which have "_AA" in their variable names), or if it was used by 300 or more applicators in Phase II (B-list variables). Because there were many potential crop-pesticide, animal-pesticide, and noncrop-pesticide pairs, more detailed information about pesticides and how they were used was placed in a separate analysis file called the Private Applicator Supplemental Pesticide File, which is described in the next section.

The Private Applicator File contains the indicator variables for the chemicals on the A list and the B list (see Section 3.2.2.1). ¹² It also contains indicator variables for the functional and chemical groups with the same list of chemicals as defined in Phase I. Table 4-2 lists the variable names for these indicators.

The master Private Applicator File contains the following set of fields for each of the 83¹³ specific pesticides on the A list, as well as the Phase III indicator flags for the pesticides on the B list.¹⁴

1. Phase III Personal Use Indicator Flag (e.g., P3_FUMIGANT_A_1, which is the indicator flag for Methyl Bromide (PCCode=053201)). --These flags take the values:

0 = did not report *personal* use of this pesticide

1 = reported *personal* use of this pesticide

For A-list or B-list chemicals reported by participant in Phase III, when 0 days are reported the personal use indicator is set to 0, otherwise it is set to 1.

In Phase III supplemental file when P3_CRANNC_IND was missing, the participant's information from the Phase II supplemental file was used to populate the value. When information was not available in Phase II, the P3_CRANNC_IND value was set to **other**.

- 4. Total days of use since enrollment (e.g., P3_FUM_RY_A_TOTAL_DAY_USE1) These variables are the product of the number of Phase II years times the number of Phase II Days per Year. Phase II years are calculated as the difference between the Phase II reference year and the enrollment year.

- 6. Phase III Intensity Days (e.g., P3_V2_FUM_RY_A_INTENSITY_DAYS1) –These variables are equal to the total days of use since enrollment times the average algorithm intensity score.

¹³ Permethrin applied to crops and Permethrin applied to animals are treated as separate pesticides for this purpose. In addition, the variable P3_INSECTICIDE_A_PERM was created to reflect overall Permethrin exposure. It is set to 1 if Permethrin was used for any purpose or 0 otherwise.

¹⁴ The derivation of these variables is discussed in Sections 3.2.2 and 3.2.3.

The master Private Applicator File also contains combined Phase I, Phase II and Phase III pesticide exposure data for each of the pesticides on the A-list:

- 7. Cumulative Lifetime Days (e.g., P3_FUM_A_LIFE_DAYS_1) The sum of the Phase I Days, Phase II Days and the Phase III days for the pesticide.
- 8. Cumulative Lifetime Intensity Days (e.g., P3_V2_FUM_A_LIFE_INTDAYS_1) The lifetime intensity days for each pesticide is product of cumulative Phase III lifetime days and the average intensity score

4.2 Private Applicator Supplemental Pesticide File

The Private Applicator Supplemental Pesticide File contains one record for each triplet of a participant ID, crop/animal/noncrop to which a pesticide was applied, and pesticide name. There are 110,544 records in the file.

The file contains the pesticide name as recorded by the interviewer; a standardized pesticide name; the specific crop, animal, or noncrop to which the pesticide was applied by the respondent; an indicator variable identifying the target usage as crop, animal, or noncrop; an indicator variable identifying the pesticide type as herbicide, insecticide, fumigant, or fungicide; PC codes for each pesticide (any not needed are set to missing); and the detailed information asked about pesticides applied to crops, animals, and noncrops.

4.3 Spouse File

The Spouse File contains responses to the questions in the Phase III CATI interviews of spouses of private applicators. It contains 19,959 records. Of these, 13,874 are from Iowa spouses and 6,085 are from North Carolina spouses.

Since the same questionnaire was used for both applicators and spouses in Phase III, the structure of the Spouse File is the same as that of the Private Applicator File with the exception that the Spouse File does not include a set of derived variables representing lifetime days of pesticide use and lifetime intensity weighted days of use. For applicators, these variables relied on Phase I variables that

contain the number of years of use and the average numbers of days of use of each pesticide. This information was not collected for spouses in Phase I. Since this quantitative usage information was not collected for spouses during Phase I, the lifetime (Phase 1 + 2 + 3) days and lifetime intensity weighted days could not be calculated for spouse file.

4.4 Spouse Supplemental Pesticide File

The Spouse Supplemental Pesticide File contains one record for each triple of a participant ID, crop/animal/noncrop to which a pesticide was applied, and pesticide name. There are 3,963 records in the file. The structure of the file is the same as the structure of the Private Applicator Supplemental Pesticide File. Refer to the Spouse Supplemental Pesticide Codebook in the appendices for a detailed description of the file.

5. USAGE NOTES

The purpose of this chapter is to provide guidance to users with respect to issues that they are likely to encounter while analyzing the Agricultural Health Study data files. The following topics are included:

- How to link files for analyses;
- Discrepancies between Phase I and Phase II Files;
- Definition of Exposure Measures;
- Unusual Values;
- Interpretation of Missing Data Patterns;
- Alternate Calculations of Lifetime Days Values; and
- Topics Discussed in Phase I and Phase II User Manuals that May Be of Interest

Each of these topics is discussed in a separate section below.

5.1 How to Link Files for Analyses

All Phase I and Phase II AHS files contain a key variable named PARTID, which is the household identifier assigned at enrollment to a pesticide applicator. The value for PARTID is identical in the Private Applicator Files and Spouse Files for husbands and wives. Since the questionnaire files contain either applicator data or spouse data, PARTID is sufficient to uniquely identify a participant within one of these files.

Several files contain data from both applicators and spouses. These are the Demographic File, the Cancer Registry File, and the Mortality File. The Demographic File contains one record for each member of the AHS cohort. To correctly match records in the Demographic File to one of the questionnaire files, it is necessary to use the variable AP_SPOUSE in conjunction with PARTID. AP_SPOUSE has the value "C" for commercial applicators, "P" for private applicators (farmers), and "S" for spouses of private applicators. The Cancer Registry File, the Mortality File, and the Buccal Receipt File also contain records for both applicators and spouses. As with the Demographic File, to correctly match Phase III questionnaire data to these files, it is necessary to use the variable AP_SPOUSE in conjunction with PARTID. Note that no commercial applicators were interviewed in Phase III, so there is no instance in which a Phase III questionnaire record will match a record which has an AP_SPOUSE value of "C".

5.2 Discrepancies between Phase III Files and Files from Earlier Phases

Analysts should be aware of a number of discrepancies between similar data items in the Phase I, Phase II, and Phase III data files. These are most apparent with Phase I values preloaded into the CATI questionnaire. The preloaded variables in the Phase III questionnaire represent gender, birth date, and enrollment information as it existed in the AHS master Demographic file at the time the CATI interviews were conducted. The values for gender and birth date were verified during the Phase III interview. If the respondent corrected these values, the change was reflected in the Phase III data files, as well as in the Phase II data files. The latest version of the Demographic File represents the best current information available to the study from all sources on participants' demographics. The analyst should

always check the release number of a file when there are apparent discrepancies. Also note that it is AHS policy that release numbers of the underlying data files be included in all reports of study data.

Some information, such as facts about farm wells, was not checked across questionnaires at the time of the interviews. Differences in responses to such questions may represent changes of facts (a new well may have been drilled) or simply changes in responses by respondents that reflect acquisition of new knowledge, lapses in memory at the time of one of the data collection events, or any number of other reasons. Such discrepancies are to be expected in a series of lengthy questionnaires administered approximately 5 years apart. If the number and size of such differences are small, they are likely to have minimal impact on standard errors. If there are many such differences, or if the magnitude is large for a specific variable used in an analysis, the investigator should consider the potential implications for any results and whether or not it is worthwhile attempting to collect additional information from the respondents.

5.3 Unusual Values

As with any large-scale survey, respondents sometimes gave unusually high or low values in response to questions. Many of these were screened out during the interview by soft and hard range checks in the interview instrument. When a soft range check was violated, the interviewer was informed and either corrected his or her keying or asked the respondent to confirm the response. Hard range checks blocked the entry of out of range values.

As discussed in Section 3.1, the Coordinating Center repeated both the hard range checks and embedded logics within the instrument. Any unusual values that had been detected by the soft range checks and approved by the field stations were verified.

While we are confident that unusual values accurately represent what the respondent told the interviewer, analysts should still check for outliers in their analysis variables and consider what, if any, action they need to take to ensure that their analyses are not adversely affected. One set of covariates of interest which has a large number of outliers is the responses to the drinking questions. For instance, there are 9 private applicators who stated that they had 30 or more drinks on a typical weekend. Two respondents claimed 40 drinks.

5.4 Interpretation of Missing Data Patterns

Data may have missing values because responses to initial questions caused the interview to branch around some questions, because the respondent stated that he or she did not know an answer, because the respondent refused to answer a question, because the respondent ended the interview early, or because of anomalies introduced while editing the CATI responses. All missing value codes for numeric values are coded with a SAS missing value. This value is ".D" when the respondent's response was "Don't know." The value is ".R" when the respondent refused to answer a question. The value is ".P" when the value is missing because the respondent did not complete the interview.. All other numeric missing value codes are a period (".") with no further distinction. Missing value codes for character variables are blanks.

5.5 Alternate Calculations of Lifetime Days Values

In Phase III, we created total lifetime days in two ways: 1) the product of the days per year and the total years reported in Phase III and 2) summing the data from Phases I, II, and III in a manner similar to Phase II. For the second method, we assumed that the pesticide was used in all years between the last interview and the year before the last interview (or the year last applied pesticides) unless the responses to questions 3.3 and 4.6 told us otherwise.

As discussed in Section 3.2.3.6, we calculated at Phase III Years of Usage variable for each pesticide as the minimum of the number of years since the last interview (NYRS_PH3_LAST), and the responses to question 3.3 ("Since <year of last interview>, for how many years did you personally mix, load, handle or apply any of these chemicals?") and question 4.6 ("For how many years over your lifetime have you personally mixed, loaded, handled, or applied this pesticide. We then multiplied this value by the number of days the respondent applied pesticides to create the P3 contribution to lifetime use of that pesticide. This estimate of the number of Phase III days of use for the pesticide was then added to the total lifetime days at the end of Phase II (or Phase I for those who did not complete the Phase II interview) to create a total lifetime days of use for that pesticide.

The rationale for this second method was to maintain the prospective nature of the data collection and to use comparable data for all phases. Recalled data can underestimate past use, and current use patterns may not accurately reflect historic use with regard to days per year applied.

Additionally, for individuals who did not report use of that chemical in Phase III, there was no updating of lifetime use, so data from these individuals would need to use the sum of the Phase I and II data. To keep all data comparable, we created this second variable.

To use Alachlor as an example, the variables P3_HRB_A_RPT_LIFE_YRS_7 and P3_HRB_A_DAYSPERYR_7 contain the values reported during the interview to questions about the total number of years the respondent used Alachlor and the average number of days per year that he or she did so. These values were multiplied together to calculate the total days that the respondent used Alachlor in his or her lifetime, variable P3_HRB_A_RPT_LIFE_DAYS_7. The alternate method first calculated P3_HRB_A_YRS_7, the number of years that the respondent used Alachlor during Phase III and multiplied it by P3_HRB_A_DAYSPERYR_7 to obtain P3_HRB_RY_A_TOTAL_DAYS_USE7, the total days that the respondent used Alachlor during Phase III. This was then added to the corresponding numbers of days of Alachlor usage from Phase I (A_HERBICIDE_LIFE_DAY7) and Phase II (A2_HRB_RY_A_TOTAL_DAYS_USE7) to obtain the alternate estimate for the number of days the respondent used Alachlor during his or her lifetime (variable P3_HRB_A_LIFE_DAYS_7). Analysts will need to determine whether variable P3_HRB_A_RPT_LIFE_DAYS_7 or variable P3_HRB_A_LIFE_DAYS_7 is better to use for a particular analysis.

We also created intensity adjusted lifetime exposure estimates for each of these lifetime exposure days as described in Section 3.2.3.12 and Section 3.2.3.15. Note that the alternate method for estimating lifetime exposure was used only for applicators as years and days of use questions were not asked of spouses during Phase I.

5.6 Topics Discussed in Phase I and Phase II User Manuals that May Be of Interest

There are a number of topics discussed in the AHS Phase I Data File Users Manual that are also pertinent to analyses of the Phase III AHS data.

- Identifying Appropriate Reference Groups (see Phase I Manual, Section 5.3)
- Pesticide Grouping Analyses (see Phase I Manual, Section 5.4)
- Pesticides Used in Combination with Other Pesticides (see Phase I Manual, Section 5.7)

5.7 Coding of Frontline

There are a number of pesticides that are named "Frontline." All of them are coded as an herbicide with the exception of products applied to animals. Products applied to animals that were specifically identified by the respondent as "Frontline Plus" are listed as "Frontline Plus" in the Phase 3 Supplemental Peticide Files. Other Frontline products applied to animals are listed as "Frontline Insecticide." Frontline Insecticide has the active ingredient Fipronil (PCCode 129121). Frontline Plus has the active ingredients Fipronil (PCCode 129121) and S-Methoprene (PCCode 105402).





When the respondent had the option to choose multiple items from a list, the numeric codes corresponding to the responses were stored in an array in the data collection instrument. The entries in the array were in the order in which the respondent named the item. To make these responses easier to analyze, we created an indicator variable or flag for each of the possible responses. An indicator variable/flag is set to the value 1 if the respondent named the corresponding item and is set to zero if he or she did not name the item. One of the responses to these questions is "Other, specify" and a follow-up question was used to capture the name of the new item. As described in the data cleaning section (Section 3.1), data management staff reviewed these responses and created new numeric codes and variables to represent many of the new responses. Question 2.3, which asks the respondent to name the crops raised on the farm, is an example both of indicator variable creation and of the creation of additional codes and variables to reflect the responses to the "Other" question.


