Gateway EDI (GEDI) NPI Readiness

- Accepting claims with dual identifiers
- Accepting electronic remittance advices with dual identifiers
- Actively testing with trading partners on both dual identifier and NPI only transactions
- Currently developing a solution for claims status and eligibility transactions to support the NPI





GEDI Implementation Issues

- Varied Payer Implementation
 - Schedules
 - Requirements
 - Provider ID's
 - Enrollment / Crosswalks
 - Taxonomy Codes
 - Zip + 4
 - Communication
 - Unannounced Changes
 - Difficulty Finding an Informed Technical Contact
 - Post May 23rd, 2007 Plans





GEDI Implementation Issues

- Procrastination & Denial
 - Only 30% of Providers Reporting NPI
 - Common Belief that the NPI "Won't Stick"
- Additional staffing costs
 - Format Changes
 - Trading Partner Testing / Configuration
 - Re-Enrollment
 - Clients Without Vendor Support
 - Education and Outreach

- Application Procrastination
- Enumeration and Subparts Confusion
- NPI Dissemination
- Differing Payer Requirements
- Differing Payer Implementation Schedules
 - Prior to May 23rd, 2007
 - Post May 23rd, 2007
- Crosswalks
- Enrollment
- Taxonomy Code Confusion
- Denial
