#### **Charge of NHQR & NHDR**

- Healthcare Research and Quality Act (PL. 106-129)
  - Health and Human
     Services Secretary required
     to submit annual report to
     Congress
  - National trends in health care quality (NHQR)
  - Prevailing disparities in health care delivery as it relates to racial factors and socioeconomic factors in priority populations (NHDR)

- Institute of Medicine,2002 and 2010
  - Stratify all quality measures
  - By OMB race and Hispanic ethnicity categories
  - By socioeconomic status variables (e.g., income, education)
  - By insurance status


#### NHQR / NHDR Constraints / Choices

- Extant data only, but standardize
- SES Hierarchy / HP2010
  - Household income relative to federal thresholds: <1x, 1-1.99, 2-3.99, 4+</li>
  - Individual education: <12 yrs, 12, >12
  - Insurance type:
    - <65: Any private, public only, none</p>
    - 65+: Medicare + private, Medicare + public, Medicare only
  - Area income: Quartiles
- Not composite




## Achievable Benchmarks of Care for Disparities Eliminations (A-E)


Figure 2.29. Adults age 65 and over who reported ever receiving pneumococcal vaccination, by race, ethnicity, and income, 2000-2008






## Stratified Analyses: Adults Reporting Poor Communication









# Regressions: Adjusted % of People <65 Uninsured All Year






### Disparities in Core Measures: Quality (L) and Access (R)









### Variations in Magnitude of Disparities Across States



Income			
	Below US poverty line	Percentage of persons below the federally defined poverty line	-0.79
	Median income	Median household income	0.85
Wealth			
	Property values	Median value of owner-occupied homes	0.64
Education			
	Low education	Percentage of persons aged > 25 years with less than a 12th-grade education	-0.84
	High education	Percentage of persons aged > 25 years with at least 4 years of college	0.79
Housing			
	Crowded households	Percentage of households containing one or more person per room	-0.56



#### **SES** Issues

- Most federal surveys collect income, education, and insurance in ways that can be standardized.
- Information of wealth and childhood SES generally not available.
- In health care, SES factors related to financial assets (income, wealth) can have different effects than SES factors related to social assets (education, spouse's education, health literacy).
