



QUESTION	ALLERGAN	
What types of behaviors or behavioral changes should raise red flags in terms of reliability or biosecurity?	All deceptive, illegal, destructive, and 'suspicious' behaviors, and non-approved research	
- To whom should concerns be reported?	Supervisor, HR, Ethics Hotline (800 Number), or to the Allergan Chief Compliance Office	
-What protections should be in place for the reporter? For the subject of the report?	Extreme confidentiality for both the reporter and the report. Very limited distribution of information. VP HR manages procedural aspects	
- How can frivolous or retaliatory reporting be discouraged?	Encourage all reporting, management process would sort through elements. Desire to have more info than less, the set point must be low enough to not miss significant issues	
- How and to what extent can privacy and confidentiality be maintained?	Via company policy and practices, managed through HR	
- How can institutions dispel any stigma associated with reporting concerning behaviors?	Allergan Code of Conduct and Ethics; All employees trained with annual (LMS)	
- What legal implications should an employer consider in implementing a peer-reporting program?	Potential increase in retaliation claims and employee relations issues which could lead to arbitration.	
- What are the best ways to protect the rights of a person who is reporting the concerning behavior of a supervisor or other superior?	Direct reporting to HR or the ethics hotline where report may be made anonymously
