**PURPOSE:** The U.S. Nuclear Regulatory Commission (NRC) will meet with the public to discuss the NRC's current regulatory oversight status of San Onofre Nuclear Generating Station. The NRC staff will discuss the status of its inspection and technical evaluation of Southern California Edison's October 3, 2012, response for Unit 2 to the March 27, 2012, NRC Confirmatory Action Letter. The NRC will respond to questions about our current inspection and evaluation activities associated with the replacement steam generators at San Onofre Nuclear Generating Station.
