### States earn over \$2.1 billion in Federal mineral receipts

**DENVER** – The Department of the Interior's Office of Natural Resources Revenue (ONRR) announced today that more than \$2.1 billion was disbursed to 36 states as part of the state share of Federal revenues collected in Fiscal Year 2012 from energy and mineral production that occurred on Federal lands within their borders, and offshore on the Outer Continental Shelf.

States receiving revenues during Fiscal Year 2012 include:

Note: Included in the state disbursements is the \$313,999 disbursed to four coastal states and eligible political subdivisions – or counties and parishes – under provisions of the Gulf of Mexico Energy Security Act of 2006 (GOMESA). GOMESA provides that the four Gulf coastal states (Alabama, Louisiana, Mississippi and Texas) and their eligible coastal political subdivisions receive 37.5 percent of the oil and gas qualified leasing revenues from certain Outer Continental Shelf areas.

Also included in the state disbursements is \$3.7 million disbursed directly to individual counties in nine states from geothermal energy production. This list also includes 8(g) payments to states. The Department's Budget-in-Brief that accompanies the President's Budget includes 8(g) in the Grants and Payments appendix, not in the Mineral Revenue Payments to States appendix.
