Updated VA Fee Cost Schedule

VA Central Office continually analyzes VALERI claim payment data and considers revisions to the amounts on our Fee Cost Schedule to accommodate changing market conditions. Today we posted an updated schedule on our website at http://www.benefits.va.gov/homeloans/valeri.asp. This revision includes a number of changes that our field stations submitted based on their experience processing claims and reviewing appeals in VALERI.

This new version of the VA Fee Cost Schedule is effective immediately. The updates are detailed below and will be temporarily displayed in red on the online schedule that can be accessed at the website address above. VALERI will apply these revisions to all claims that are processed in the application from this point forward.

Appeals

As always, servicers can appeal any items that are denied or limited in VALERI by providing documentation justifying a higher expense. VA Loan Guaranty staff will continue to review these appeals and consider payment above the published maximum amounts within reason. This is especially important for items over which the servicer has no control, such as foreclosure facilitation/recording/filing fees or other items that may be established by local governmental or independent authorities.

Application of Previous Fee Schedules

Please also note that as of Monday, May 16, 2011, VALERI has been programmed to maintain and apply the full history of Fee Cost Schedule changes. All items will be paid based on the maximum allowable amount on the published schedule as of either the date the work was completed or the loan termination date. This logic has been applied to all Basic Claims, Appeals and Supplemental Claims in the VALERI application.

All changes are effective immediately, but they will be released into VALERI in two phases. The following updates will be reflected in VALERI by Thursday, May 26, 2011:

The fees listed below require more in-depth coordination involving the Claims Bulk Upload file and SWP. The changes will not be fully implemented in VALERI until the 2.11 release on August 6, 2011. However, please note the following effective dates for these items:

- Reimbursement for Relocation Assistance took effect immediately with the release of <u>VA Circular 26-11-1</u> on January 6, 2011. VA will continue to reimburse servicers for this item, as noted on the circular.
- Reimbursement for Statutory Required Mail will begin immediately, but these changes will not be fully reflected in VALERI until August 6, 2011.
