SUMMARY

DV Web State Software 4.2.5 has been installed on your system.

Due to changes to the ETA 227 report, changes to three Data Validation populations for Benefits were required and a new population had to be added. Populations12, 13, and 14 have been modified and a new population; Population 15, "Overpayments Established by Method" has been added to the Data Validation Software. The changes listed below will apply to new extract files with reporting periods for VY2013 and later.

Population12:

- The title for Population 12 has been changed from "Overpayments Established" to "Overpayments Established by Cause;"
- The field "Detection Type" was deleted from the extract file and five (5) new fields (EB amount, Accumulated UI amount, Accumulated Fed Amount, Accumulated EB amount, and Date of Original Monetary) were added to the extract file;

Population13:

Population14:

- The field "Outstanding Overpayment" was eliminated and one new field, "EB Balance at the End of Qtr," was added to the extract file;
- New reported lines were added to validate new reporting cells in the ETA 227 report;
- A new Group 14.04 was added to the View Reported Counts screen; and
- New subpopulations (14.17 14.24) were added;

The "Help Screens" were also modified to provide information on both new and old extract files for Benefits Populations 12, 13 and 14 and the new Population 15.

Existing issues that were also fixed in this release:

- The report validation scores for benefits populations 13 and 14 were fixed in the application to display the correct scores in the View Population Scores window when all the groups in View Report Validation Screen Pass. The scores are displayed correctly in the View Population Scores and the View Report Validation Screens.
- The software was fixed to display samples when the sample size is less than two in View Samples Screen.
- The record layout for Benefits Population 1 was changed to display the text in Data Type/Format column of the WBA field from "Required" to "Required except optional for Interstate filed from Agent Claims".
