SUBJECT: SHOULDER SLEEVE INSIGNIA (SSI) AND SHOULDER SLEEVE INSIGNIA-FORMER WARTIME SERVICE (SSI-FWTS) 1. AR 670-1, 3 FEB 05, WEAR AND APPEARANCE OF ARMY UNIFORMS AND INSIGNIA.

- 2. THE PURPOSE OF THIS MESSAGE IS TO REEMPHASIZE THE WEAR POLICY FOR BOTH THE SSI AND SSI-FWTS. COMMANDERS AND LEADERS AT ALL LEVELS WILL COMPLY WITH AR 670-1, PARAGRAPH 28-16, PARAGRAPH 28-17, AND APPENDIX F.
- 3. UNITS ARE NOT AUTHORIZED TO MAKE MODIFICATIONS TO THEIR SSI, OR SSI-FWTS WITHOUT PRIOR APPROVAL FROM THE DEPUTY CHIEF OF STAFF (DCS), G-1. A MIRROR IMAGE SSI-FWTS IS CONSIDERED A MODIFICATION.
- 4. TO DATE, THE DCS, G-1 HAS NOT APPROVED ANY AUTHORIZATIONS FOR UNITS TO WEAR A MIRROR IMAGE SSI-FWTS NOR HAVE ANY APPROVALS BEEN GRANTED FOR UNITS TO MODIFY THEIR SSI OR SSI-FWTS.
- 5. UNITS WHO ARE NOT IN COMPLIANCE WITH THE CURRENT POLICY OUTLINED IN AR 670-1, PARAGRAPH 28-16, PARAGRAPH 28-17, AND APPENDIX F WILL COMPLY IMMEDIATELY.
- 6. IAW WITH AR 670-1, PARAGRAPH 28-16E, THE FOLLOWING GUIDELINES WILL BE ADHERED TO:
- A. NON-SUBDUED. ALL PERSONNEL WILL WEAR THE NON-SUBDUED SSI OF THEIR CURRENT ORGANIZATION CENTERED ON THE LEFT SLEEVE, 1/2 INCH BELOW THE TOP OF THE SHOULDER SEAM, ON THE COAT OF THE ARMY GREEN UNIFORM. WHEN THE SAPPER, RANGER, SPECIAL FORCES, OR PRESIDENT S HUNDRED TAB IS WORN, THE TAB IS PLACED 1/2 INCH BELOW THE TOP OF THE SHOULDER SEAM. THE SSI IS WORN 1/4INCH BELOW SPECIAL SKILL OR MARKSMANSHIP TABS. IF THERE IS SIMULTANEOUS WEAR OF TWO TABS OR MORE, THE SSI REMAINS AT 1/4INCH BELOW THE TABS. TABS THAT ARE AN INTEGRAL PART OF A SSI, SUCH AS AIRBORNE OR MOUNTAIN, ARE WORN DIRECTLY ABOVE THE SSI WITH NO SPACE BETWEEN THE INSIGNIA AND TAB. PERSONNEL WILL NOT WEAR NON-SUBDUED SSI ON UNIFORMS OTHER THAN THOSE SPECIFIED.

 B. SUBDUED. ALL PERSONNEL WILL WEAR THE SUBDUED SSI ON THE TEMPERATE, HOT-WEATHER. ENHANCED HOT-WEATHER. AVIATION. DESERT BATTLE DRESS
- B. SUBDUED. ALL PERSONNEL WILL WEAR THE SUBDUED SSI ON THE TEMPERATE, HOT-WEATHER, ENHANCED HOT-WEATHER, AVIATION, DESERT BATTLE DRESS UNIFORM AND ARMY COMBAT UNIFORM (ACU); FLIGHT SUIT AND FLIGHT JACKET; COMBAT VEHICLE CREWMAN UNIFORM AND THE BATTLE DRESS UNIFORM FIELD JACKET. PERSONNEL WILL NOT WEAR SUBDUED SSI ON HOSPITAL DUTY AND FOOD SERVICE UNIFORMS. POSITIONING OF THE SUBDUED INSIGNIA IS IDENTICAL TO THE NON-SUBDUED INSIGNIA, OUTLINED IN 6A ABOVE, FOR ALL UNIFORMS EXCEPT THE ACU. THE SUBDUED SSI IS WORN CENTERED ON THE HOOK AND LOOP-FACED PAD ALREADY PROVIDED ON THE LEFT SLEEVE OF THE ACU COAT.

- 7. THE FOLLOWING GUIDANCE IS PROVIDED FOR DETERMINING THE APPROPRIATE SSI TO BE WORN AS THE SSI-FWTS:
- A. A DEPLOYED UNIT THAT IS AUTHORIZED TO WEAR AN SSI IN ITS OWN RIGHT WILL WEAR THAT UNIT'S SSI AS THE SSI-FWTS. THIS IS TRUE REGARDLESS OF WHETHER THE HEADQUARTERS ELEMENT DEPLOYS, AND REGARDLESS OF THE NUMBER OF CHANGES TO THE UNIT'S ALIGNMENT OR OPERATIONAL CONTROL
- (OPCON) DURING THE PERIOD OF DEPLOYMENT.
- B. WHEN A UNIT NOT ENTITLED TO ITS OWN SSI DEPLOYS, THE OPCON RELATIONSHIP PRIOR TO DEPLOYMENT IS TERMINATED AND A NEW OPCON RELATIONSHIP IS ESTABLISHED. MEMBERS OF THESE UNITS WILL WEAR THE SSI OF THE LOWEST ECHELON DEPLOYED UNIT ENTITLED TO AN SSI IN EACH OF THEIR NEW DEPLOYED CHAINS OF COMMAND AS THEIR SSI-FWTS.
- C. WHEN THERE IS NO INTERMEDIATE UNIT THAT HAS ITS OWN SSI IN THE DEPLOYED CHAIN OF COMMAND, MEMBERS OF UNITS NOT ENTITLED TO THEIR OWN SSI WILL WEAR THE SSI OF THE SENIOR ARMY COMMAND IN THE THEATER AS THEIR SSI-FWTS.
- D. SOLDIERS WHO ARE CROSS-LEVELED, ASSIGNED, ATTACHED, OR AUGMENTING DEPLOYED UNITS, AND SOLDIERS WHO ARE TDY ON ORDERS (DD FORM 1610), WILL WEAR THE SAME SSI-FWTS WORN BY MEMBERS OF THE DEPLOYED UNIT TO WHICH ATTACHED OR OPCON. THIS DOES NOT APPLY TO MEMBERS OF US ARMY TRIAL DEFENSE SERVICE OR CIDC, WHO WILL WEAR THE SSI OF THEIR RESPECTIVE COMMANDS AS THEIR SSI-FWTS.
- E. SOLDIERS AUTHORIZED TO WEAR MORE THAN ONE SSI-FWTS MAY CHOOSE WHICH SSI-FWTS TO WEAR. SOLDIERS ALSO MAY ELECT NOT TO WEAR THE SSI-FWTS.
