- 1. THIS MESSAGE SERVES AS IMPLEMENTING INSTRUCTIONS FOR CHANGES TO THE WEAR POLICY OUTLINED IN AR 670-1, PARAGRAPH 29-7, DATED 3 FEBRUARY 2005.
- 2. PARAGRAPH 29-7: ADD: 29-7C GOLD STAR LAPEL PIN: SOLDIERS WHO HAVE LOST AN IMMEDIATE FAMILY MEMBER IN COMBAT ARE AUTHORIZED TO WEAR THE GOLD STAR LAPEL PIN ON THE ARMY GREEN AND ARMY BLUE UNIFORMS. AN IMMEDIATE FAMILY MEMBER IS DEFINED AS A SPOUSE, MOTHER, FATHER, STEPPARENTS, CHILDREN; INCLUDING STEPCHILDREN, SISTERS; INCLUDING STEPSISTERS, BROTHERS; INCLUDING STEPBROTHERS; A PERSON IN LOCO PARENTIS, AND ONLY LIVING BLOOD RELATIVES. HOW WORN: ENLISTED SOLDIERS WILL WEAR THE GOLD STAR LAPEL PIN CENTERED BOTH VERTICALLY AND HORIZONTALLY ON THE LEFT LAPEL OF THE ARMY GREEN AND ARMY BLUE UNIFORMS. OFFICERS WILL WEAR THE GOLD STAR LAPEL PIN CENTERED ON THE LEFT LAPEL 1/4 INCH BELOW THE BRANCH INSIGNIA.
