





Life-Cycle Support

- Army Training Inventory
 - 335,000 training devices located at over 600 sites worldwide
 - Sustained by 7,000 people
 - Valued at \$3.9B
- Life-Cycle Management Plan is required to support training systems
- MDEP WCLS is PEO STRI's sustainment budget line for Army accepted TADSS
- Field OPS operates 24/7 around the world – "the sun never sets on their support"

- 850 PM Field OPS Contractor Personnel at over 25 locations deployed in SWA
- Since March 2003 we have supported over 775,000 individual Soldier training events in SWA
 - ✓ Joint Forces: Army, Marine Corps, Air Force, Navy, SOCOM
 - ✓ 9+ Coalition Nations including: United Kingdom, Australia, Italy, Norway, Poland, France, Netherlands, Lithuania, Canada, and New Zealand
 - ✓ More than 486,000 Iraq Army and Afghan National Army Soldiers trained to date

The Army:

- Has focused on Counterinsurgency/Stability Operations for 10 years
- Is concluding it's operations in the Middle East
- Has not emphasized conventional operations along the Full Range of Military Operations (ROMO) in the last decade
- Is returning to a future of:
 - constrained resources,
 - environmental training limitations,
 - training challenges across a myriad of potential operations, and
 - fewer soldiers needing to do more in their allotted training time
- Must maximize the Return on Investment of every training dollar





The Army recognizes and supports the significant role simulation training will play in attaining future Warfighter readiness requirements.

Army guidance states:

The (System) PEOs, DRPMs and PMs will:

• Per AR 70-1:

- coordinate...system TADSS acquisition strategy...to ensure compliance with established joint live, virtual, constructive (LVC) training architectures and network environments.
- develop TADSS...interoperable across the LVC training environments, and support operational, institutional, home station, Combat Training Center, and deployed training.
- ensure programs can provide the requisite training aids and devices, and...the programs can be supported fully before granting approval to field the system.
- establish a continuing relationship...collaborate...coordinate...with PEO STRI.

Per Shyu Memorandum – 20 Dec 11 (COE Directive for PEOs):

 coordinate with PEO, Simulation, Training and Instrumentation to enable CE-compliant systems to embed, integrate or interoperate with test and training applications and systems. 15

PEO STRI is the critical lead in ensuring all training solutions are appropriately integrated and synchronized across the Army in support of the COE.





Simulation Enhances Live Training

Why Simulation?

Simulation provides a means of training tasks that cannot be done on a system:

- Cannot replicate on an actual helicopter:
 - Reaction to Loss of Tail Rotor Physical
 - Reaction to Severing of Drive Shaft -Physical
 - Reaction to Stuck Pedal Physical
 - Complete Engine Failure Safety
 - Engine Performance Manipulations Safety
 - Autorotation with Complete Engine Failure -Safety
- Cannot replicate on actual vehicles:
 Vehicle Rollover Training –
 Damage/Safety
