
## MECC's Structure

The committee is comprised of the Ministers of Health of all MECC countries and is chaired by the US Secretary of Health & Human Services. The committee is responsible for approving the annual budget, all new projects and the acceptance of new countries as member states. It usually convenes once a year, during the WHA in Geneva, Switzerland.

The committee comprises of one representative from each MECC member, who is nominated by the respective Minister of Health. The committee is responsible for all the ongoing programs and projects. It convenes once a year in either in the Middle East or Europe. Its chairman is elected by the committee's members.

The PIs are appointed by their respective Ministers of Health and are in charge of the day today activities of the cancer registry in their jurisdiction. Once a year they report to the Cancer Registry Steering Committee.


# MECC's Accomplishments

## Regional Project No. 1 – Cancer Registries :

The project involves the collection of national incidence data through the use of the MECC Manual of Standards for Cancer Registration, and a special computer program – CanReg.

The collected data are used for comparison studies both within the region and with those of the USA SEER project.





## F. NCI – Cancer Registry Monograph, 2006



This project represents a decade of hard work and collaboration among scientists in the region and is a model for international scientific collaboration in troubled regions of the world.

**A few of the major findings are:**

1. Liver cancer incidence rates in Egyptians were 5-7 times as high as those of the other MECC populations.
2. Egyptians and Israeli Jews had higher rates of non-Hodgkin Lymphoma.
3. Jordanians had the lowest incidence of cancer.

## Regional Project No. 2 – Small Grants / Fellowships :

**The Small Grants** Program of MECC has funded investigators representing the entire MECC membership for collaborative research projects. Over 40 such projects have been funded in basic science, clinical science, and epidemiology / population science. These grants have served to foster cross-border collaborations since this has been a requirement for funding. Applicants have come from academic institutions, hospitals, governmental health agencies.







**The MECC Fellowship Program** is aimed at training and education of the next generation of cancer researchers. These fellowships provide an opportunity for exchanges of scientists within the region as well as training in the United States and Europe. In clinical science, fellowships have included radiation oncology, medical oncology, pathology, hematology, and pediatric oncology. Basic science fellowships and fellowships in epidemiology have also been supported by MECC. Fellowships range from a few months to a couple of years after which the fellowship recipients return to their home institutions bringing skills that upgrade clinical practice or enable research.





## Epilogue

Since the signing of the historic agreement forming the Middle East Cancer Consortium (MECC) in 1996, the United States has had two Presidents (one from each political party), three Secretaries of the Department of Health and Human Services (DHHS), two Directors of the National Institutes of Health (NIH), and three Directors of the National Cancer Institute (NCI). The NCI was instrumental in the establishment of MECC, and then DHHS Secretary Donna Shalala formally witnessed the signing ceremony in Geneva. Former DHHS Secretary Tommy Thompson and current Secretary Michael Leavitt have continued strong U.S. support and leadership within MECC by chairing its Ministerial Steering Committee. NCI Director, Dr. John Niederhuber now serves as a member of the MECC Board of Governors as did his two predecessors, Dr. Richard Klausner and Dr. Andrew von Eschenbach. I mention these facts to make one simple point: our commitment to MECC and to the peace and well-being of the region transcends political parties and is independent of the comings and goings of individuals.

Since its inception ten years ago, MECC has provided a shining example of how geopolitical differences can be put aside to strive together toward the common goal of reducing and ultimately eliminating suffering and death due to cancer. MECC has worked to foster research collaborations through its small grants program. Another major activity of MECC has been the establishment and support for population-based cancer registries in the region. A significant milestone occurred this past year with the publication of the NCI monograph on cancer incidence in four MECC countries with comparison to the data from NCI's Surveillance, Epidemiology, and End-Results (SEER) program. In addition to its work in cancer registry, MECC activities encompass issues that range from prevention to end-of-life care with many workshops and symposia having occurred across this cancer continuum. In particular, MECC has taken on capacity building in palliative care and symptom management and has already supported several training activities related to this important topic.

On the occasion of MECC's tenth anniversary, it is tempting to look back with some pride on what has been accomplished. I would challenge us instead to look ahead and relish the possibilities of all that might be accomplished by MECC and by similar activities wherein the good of all the people of the region is allowed to proceed despite the complex political issues that swirl around us. To the many individuals who have contributed to MECC over the past decade, I wish to give my personal thanks as well as that of NCI. Well done! To those who have not yet had opportunity to contribute, our future is all ahead of us. Come join in this noble endeavor.

MECC was established in 1996 about three years following the Oslo accords. As MECC began to work in the region, it became apparent that cooperation begins and ends with people. It is the people who eventually determine the scope and nature of such cooperation. Dialogue between Arab and Israeli health professionals as well as between Cypriots and Turks continued via MECC despite historic difficulties. MECC has shown that mutual respect, goodwill and understanding can lead to true dialogue, which in turn can serve as the basis for collaboration.

MECC started its regional activity in establishing a regional cancer registry network. During the first decade, the cancer registry model relied on descriptive epidemiology techniques. The data from the individual registries were primarily utilized by policymakers within their own jurisdiction. In the coming years, it is our goal to have the data from the cancer registries form a foundation for collaborative research in the region.

Our experience with the cancer registration project made clear that sustaining such collaborative activities is a significant challenge. It also became clear that sustainable cancer registries require an ongoing training program and quality control and assurance. Centralized training and quality control have been among MECC's contributions to the individual cancer registries.

It would not have been possible to build the cancer registry network without the substantial assistance from the National Cancer Institute in Bethesda, MD and Emory University, Atlanta GA. The Ministries of Health of the MECC members have gradually taken over a larger part of the burden for the registry infrastructure, which contributes substantially to the sustainability of these surveillance centers. More recently MECC started another regional project around palliative care for the cancer patient and is drawing upon NCI and Calvary Hospital in New York for training on this important topic.

The common battle against cancer that defines MECC has proven that common ground can be found for the process of mediation between societies, even those engaged in a struggle extending over a century. Health professionals can serve as "ambassadors" to promote collaborations. Any such endeavor however must be based on mutual respect and goodwill, and patience and perseverance are also essential. As we progress into MECC's second decade, we will need to keep in mind all that we have learned over its first.
