Directions to NIST Main Campus

The headquarters site of the National Institute of Standards & Technology is located at 100 Bureau Drive in Gaithersburg, Maryland, just off Interstate Route 270, about 25 miles from the center of Washington, D.C.

From northbound I-270 take Exit 10, Route 117 West, Clopper Road. Bear right at the first light onto Clopper Road/West Diamond Avenue. At the next light, turn left onto the NIST grounds.

From southbound I-270 take Exit 11, Route 124, Montgomery Village Avenue/Quince Orchard Road. Bear right at the first light onto Route 124 West, Quince Orchard Road. After you merge onto Rt. 124, Quince Orchard Road, turn left at the second light onto Route 117, West Diamond Avenue. Turn right at the first light onto NIST grounds.

From Baltimore Take 195 West. Take 95 South Exit #4B toward Washington. Take 495 West Exit #27-25 toward College Park/Silver Spring. Take 270 North Exit #35 toward Frederick. Take 270 Local North toward Montrose Road. Enter the Collector/Distributor lanes at Exit 9 and take Exit 10, Route 117 West, Clopper Road. Bear right at the first light onto Clopper Road/West Diamond Avenue.

NIST Main Gate

We are now instituting an additional requirement for visitor vehicles entering the campus. **When a Guest/Visitor checks in at the NIST Visitor Center at Gate A and intends to drive into the campus, they will have to show two documents: a Photo I.D. (State issued driver's license, Federal ID or passport) and a Vehicle Registration card.** If a guest does not have a valid vehicle registration, they will be required to park at the Visitor Center and take the NIST Campus Shuttle. Visitors driving rental cars can show their rental agreement in lieu of vehicle registration.

Once you leave the Visitor Center, you will be asked to show the name badge you picked up and a photo ID before being admitted onto the campus. At the main entrance stop sign, make a left, follow until you see signs for the Administration Building (101) (it's the tallest building). There is visitor parking across from the Administration Building. The meeting is in Lecture Room A on the first floor. The cafeteria is also located on the first floor. Visitors must wear a visitor badge at all times while on the NIST campus.

METRO Shuttle Red Line

NIST provides shuttle service for official visitors and staff to and from the **Shady Grove Metro Station** from 6:45am to 6:00pm on the Red Line. Visitors using Metro can meet the NIST shuttle at the **east** side "**Bus Bay C**" area of the Shady Grove Metro Station at 15 and 45 minutes past the hour. The shuttle departs from the front of the NIST Administration Building on the hour and half hour. The ride between NIST and the Shady Grove Metro Station takes approximately 15 minutes, depending on traffic conditions.
