Weekly Flu View – July 7 (CDC)

During week 27, 6.1% of all deaths reported through the 122-Cities Mortality Reporting System were due to pneumonia and influenza. This percentage was below the epidemic threshold of 6.8% for week 27. http://www.cdc.gov/flu/weekly/

Severe Complications of Hand, Foot and Mouth Disease Caused by EV-71 in Cambodia – Conclusion of the Joint Investigation – July 13 (WHO)

The investigation into the illnesses and deaths in Cambodia, which mainly affected very young children, concluded that a severe form of hand, foot and mouth disease (HFMD) was the cause in the majority of cases reported to the Ministry of Health.
