Travel Warnings are in effect for 35 countries. Warnings are issued when long-term, protracted conditions that make a country dangerous or unstable lead the State Department to recommend that Americans avoid

Reports of Rare, Potentially Fatal Adverse Effect of use of Benzocaine Sprays for Medical Procedures – FDA

The FDA continues to receive reports of methemoglobinemia, a serious and potentially fatal adverse effect, associated with benzocaine sprays. These sprays are used during medical procedures to numb the mucous membranes of the mouth and throat.

Reports of Rare, Potentially Fatal Adverse Effect of use of Over-the-Counter Benzocaine for Gums and Mouth – FDA

The FDA is warning the public that the use of benzocaine, the main ingredient in over-the-counter (OTC) gels and liquids applied to the gums or mouth to reduce pain, is associated with a rare, but serious condition. This condition is called methemoglobinemia and results in the amount of oxygen carried through the blood stream being greatly reduced. In the most severe cases, methemoglobinemia can result in death.

FDA Approves First Meningococcal Vaccine for Infants – FDA (Apr 22)

The U.S. Food and Drug Administration approved Menactra in children as young as 9 months for the prevention of invasive meningococcal disease caused by *Neisseria meningitidis* serogroups A, C, Y and W-135. Menactra already is approved for use in people ages 2 through 55 years.
