

5. POLITICALLY THE WRON IS UNIFIED IN ITS SUPPORT OF JARUZELSKI'S MARTIAL LAW POLICY. THE POLITBURO, HOWEVER IS UNLIKELY TO HAVE SUCH A <u>HOMOGENEOUS</u>; ORIENTATION. BECAUSE OF THE FACT THAT THE WRON: CURRENTLY CONTROLS THE LEVERS OF POWER, IT IS LIKELY TO PROCEED AHEAD WITH THE DESTRUCTION OF SOLIDARITY AND MAY EVEN BE ABLE TO BRING ABOUT THE REMOVAL OF PZPR LIBERALS. THE SOVIETS WILL OBVIOUSLY KEEP PUTTING PRESSURE ON THE WRON TO REALIZE THESE GOALS.
