If the 1987 ISI code and industry name shown in the third and fourth columns are not in boldface, only some of the activities covered by the industry are included in the 1997 ISI code shown in the first column and the activities covered by the 1997 ISI code are shown in the fifth column. Some entries in the fifth column refer to SIC codes.
