What do we do?

The PLDD Warrant Officer Proponency

- Develops and recommends changes to the personnel classification system for Adjutant General Corps Warrant Officers as listed in DA Pam 611-21
- Monitors and recommends changes in warrant officer training, professional development, and recruiting strategies
- Advises soldiers, commanders, and personnel service units on applications for appointment as a warrant officer
- Develops prerequisites for warrant officer selection
- Develops warrant officer training strategies (but not training content). Warrant officer training and training development are the responsibilities of Training Development
- Provides warrant officer input to the Adjutant General web site
- Evaluates warrant officer application packets for technical prerequisites
- Provides recommendation on waivers of Active Federal Service (AFS) and the Army Physical Fitness Test (APFT) for warrant officer selection boards
- Assists USAREC in recruiting Adjutant General warrant officer specialties
- Coordinates AG Corps representation on warrant officer selection boards
- Evaluates unit warrant officer fill and distribution
- Promulgates information concerning warrant officer accessions, professional development, training and utilization
- Recommends changes in warrant officer personnel management policies
- Advises the National Guard Bureau on the eligibility of personnel for warrant officer specialties
- Coordinates warrant officer issues with other warrant officer proponents

## Applying for Warrant Officer

The recruiting of AG Warrant Officers for the Active Army and US Army Reserve is the responsibility of the US Army Recruiting Command (USAREC) located at Fort Knox, KY. Active Duty personnel interested in applying for warrant officer should contact their supporting personnel service activity (S-1, MPD) for information. US Army Reserve personnel should contact their local recruiter. Army National Guard (ARNGUS) applicants are evaluated for appointment by a Federal recognition board under the provisions of National Guard Regulation 600-1-1. Interested applicants should contact their State Adjutant General office or call the National Guard Bureau at (703) 607-9517/9516 or DSN 327-9517/9516.
