GARY R. BIRCHLER, Ph.D., is clinical professor of psychiatry at the University of California at San Diego (UCSD) School of Medicine and adjunct professor at San Diego State University and the University of San Diego. He serves as codirector of the UCSD/Veterans Affairs (VA) Psychology Internship Program and director of the Family Mental Health Program, VA San Diego Healthcare System. Dr. Birchler is co-investigator on three Public Health Service research grants, studying the application of behavioral couples therapy to substance-abusing patients and their partners.

PAUL P. CASADONTE, M.D., is director of substance abuse treatment programs at the New York Harbor Health Care System VA Medical Center. He is clinical associate professor in the department of psychiatry at New York University School of Medicine. Dr. Casadonte conducts clinical research on heroin and cocaine abuse and on HIV infection and prevention among drug abusers.

WILLIAM FALS-STEWART, Ph.D., is a clinical psychologist and senior research scientist at the Research Institute on Addictions at the State University of New York, University at Buffalo. His research and treatment interests include marital and family therapy with alcohol and drugabusing patients; substance abuse treatment cost, outcome, and benefit studies; and parent skills training for substance-using parents.

TERRY HORTON, M.D., is medical director and vice president of Phoenix House Foundation. A practicing internist, he is also clinical assistant professor of medicine at New York Medical College and has an appointment at the Weill College of Medicine, Cornell University. Dr. Horton's interests include community-based detoxification and the interface of substance abuse with primary health care.

VALERA JACKSON, M.S., is chief executive officer of the Village, a comprehensive social services agency in Miami, Florida. She has worked in the substance abuse field for more than 25 years. At the Village she has been instrumental in developing substance abuse and mental health services within a family systems model.

HENDRÉE E. JONES, Ph.D., is assistant professor of psychiatry at the Johns Hopkins University School of Medicine in Baltimore. She directs research at the Johns Hopkins Center for Addiction and Pregnancy, and is principal investigator for

four NIDA-funded projects examining behavioral and pharmacological interventions for drugdependent pregnant and recently postpartum women. She also directs the Cornerstone Program, a NIDA-funded project examining novel behavioral interventions to prevent relapse following residential opioid detoxification.

GEORGE F. KOLODNER, M.D., is cofounder and medical director of the Kolmac Clinic in Silver Spring, Maryland. The clinic provides outpatient detoxification, rehabilitation, and continued care for people with alcohol and other drug problems. Dr. Kolodner is also clinical associate professor of psychiatry at Georgetown University School of Medicine in Washington, D.C.

SUZANNE M. McMURPHY, M.S.S., Ph.D., is senior research associate at the University of Pennsylvania School of Medicine in Philadelphia, where she is co-investigator on several NIH-funded studies of barriers to health care.
