It will highlight the importance of HIV testing, linking people with HIV to care and treatment, appropriate use of medications to reduce the amounts of virus in the body, and how viral suppression and prevention counseling can lead to HIV

# Ready Pac Foods, Inc. Announces Voluntary Product Recall Because Of Possible Health Risk – Nov 17 (FDA)

Ready Pac Foods, Inc. of Irwindale, CA is recalling a total of 5,379 cases of bagged salad products containing Romaine lettuce, as listed below, with the Use-by Date of November 18, 2011 because they may be contaminated with E. coli (*E.coli O157.H7*). *E.coli O157:H7* is an organism that may cause diarrheal illness often with bloody stools. <u>http://www.fda.gov/Safety/Recalls/ucm280227.htm</u>

#### The J.M. Smucker Company Announces a Limited Voluntary Recall on Two Specific Best-If-Used-By Dates of 16 oz. Smucker's Natural Peanut Butter Chunky Due to Possible Health Risk – Nov 16 (FDA)

The J.M. #### Investigation Announcement: Multistate Outbreak of Human Salmonella Heidelberg Infections Linked to "Kosher Broiled Chicken Livers" from Schreiber Processing Corporation – Nov 10 (CDC)

CDC is collaborating with public health and agriculture officials in New York, New Jersey, other states, the U.S. Department of Agriculture's Food Safety and Inspection Service (USDA-FSIS), and the U.S. Food and Drug Administration to investigate a multistate outbreak of *Salmonella* Heidelberg infections linked to a kosher chicken liver product labeled as "kosher broiled chicken livers," which is not ready-to-eat and requires further cooking before eating.
