In accordance with title VIII, subtitle C, section 8306, of the U.S. Troop Readiness, Veterans' Care, Katrina Recovery, and Iraq Accountability Appropriations Act, 2007 (Public Law 110-28), the head of each Federal Agency is required to submit a report to Congress on the dollar amount of acquisitions made by the Agency to entities that manufacture articles, materials, or supplies outside of the United States.
