

### **HHS: Combating the** Silent Epidemic of **Viral Hepatitis**

"HHS is committed to ensuring that new cases of viral hepatitis are prevented and that persons who are already infected are tested; informed about their infection; and provided with counseling, care and treatment."



#### **Educate Providers & Communities**

- Build a US health care workforce prepared to prevent and diagnose viral hepatitis and provide care and treatment
- Decrease health disparities by educating communities

## Educate Providers & Communities Actions:

- CDC developing, through cooperative agreement, a medical school curriculum
- BOP training Regional Hepatitis Pharmacists on new direct acting antivirals (DAA)
- VA developing national treatment guidelines and criteria for use of DAA
- "Know More Hepatitis" campaign in development at CDC
- IHS developing youth-centered health education programs with viral hepatitis messages



### Improve Testing, Care and Treatment

- Early identification of infected persons
- Active linkage to care
- Improve access to and quality of care
- Advance research



### Improve Testing, Care and Treatment Actions:

- Update 2004 USPSTF recommendation on HCV screening underway
- HRSA/HAB funding 29 demos to integrate HCV care into HIV primary care
- AHRQ: review of Comparative Effectiveness HCV Rx in Adults
- NIH intramural research on therapy for HBV, HCV, and HDV



#### Strengthen Surveillance

- Build state and local surveillance capacity
- Monitor viral hepatitis health disparities
- Monitor provision of care and impact
- Develop new technologies



### Strengthen Surveillance Actions:

- CDC funded 5 HDs to begin integration of electronic lab reporting as a component of viral hepatitis case surveillance
- HRSA/BPHC are reporting on HBV/HCV testing and prevalence in CHCs
- VA's Clinical Case Registry software used to assess state of care locally and nationally for Veterans with HCV

#### Eliminate Vaccine-Preventable Hepatitis

- Eliminate mother-to-child transmission of HBV
- Achieve universal HAV and HBV vaccination for vulnerable adults
- Design and test new/improved viral hepatitis vaccines



### Eliminate Vaccine-Preventable Hepatitis Actions:

- CDC perinatal coordinators facilitate referral of HBV-infected pregnant women into care
- BOP will incorporate HBV prevention, testing and immunization information into its drug education program
- VA promoting HAV and HBV vaccination in Substance Use Disorder Clinics
- NIH supports portfolio of HCV vaccine research



# Reduce Viral Hepatitis Associated With Drug Use

- Ensure access to prevention and care services for IDUs
- Mobilize community resources
- Access to substance use treatment
- Expand services in correctional settings
- Advance research



# Reduce Viral Hepatitis Associated With Drug Use Actions:

- SAMHSA updating OTP (Opioid Rx Program) accreditation guidelines to include a hepatitis testing standard
- SAMHSA developing curriculum on integrating drug rx and hepatitis dx and care
- OMH will integrate viral hepatitis prevention services into HIV programs for high-risk adolescents
- OWH will include viral hepatitis education for incarcerated women re-entering communities



# Prevent Health Care Associated Viral Hepatitis

- Reduce viral hepatitis transmission from medical device misuse
- Reduce transmission associated with blood, organs and tissues
- Reduce occupational transmission
- Research to inform prevention strategies



# Prevent Health Care Associated Viral Hepatitis Actions:

- CDC-led Safe Injection Practices Coalition expanding partnerships
- CDC working on updated guidelines for HBV vaccinations of HCWs
- FDA co-sponsored summit on medical device reprocessing
- NIH research on tests to improve detection of transfusion-transmissible infections



## Proposed 2020 Goals of the Viral Hepatitis Action Plan (full implementation)

- Increase from 33% to 66% the proportion of persons who are aware of their HBV infection
- Increase from 45% to 66% the proportion of persons who are aware of their HCV infection
- Reduce by 25% the number of new HCV infections
- Eliminate mother-to-child HBV transmission



#### **How Will We Move Forward?**

- Educate, educate, educate...
- Use plan to leverage existing resources, set priorities, and advance policy
- Advances in health informatics
- Evolving health policies: expanded coverage and new models of care
