### Commerce Finds Subsidization of Certain Oil Country Tubular Goods from the People's Republic of China

- On November 24, the Department of Commerce (Commerce) announced its final determination in the countervailing duty (CVD) investigation on imports of certain oil country tubular goods (OCTG) from the People's Republic of China (China).
- For the purposes of CVD investigations, subsidies are financial assistance from foreign governments that benefit the production, manufacture, or exportation of goods.
- Commerce found that Chinese producers/exporters of OCTG have received net countervailable subsidies ranging from 10.36 to 15.78 percent.
- Mandatory respondents Jiangsu Changbao Steel Tube Co., Ltd., Tianjin Pipe (Group) Co., Wuxi Seamless Pipe Co., Ltd., and Zhejiang Jianli Enterprise Co., Ltd. received final subsidy rates of 11.98, 10.36, 14.61, and 15.78 percent, respectively. All other Chinese producers/exporters received a final subsidy rate of 13.20 percent.
- As a result of this final determination, Commerce will instruct U.S. Customs and Border Protection to collect a cash deposit or bond based on these final rates.
- The petitioners for this investigation are: Maverick Tube Corporation (TX); United States Steel Corporation (PA); TMK IPSCO (IL); V&M Star LP (TX); Wheatland Tube Corp. (PA); Evraz Rocky Mountain Steel (CO); and United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union, AFL-CIO-CLC (PA).
- The merchandise covered by this investigation consists of certain OCTG, which are hollow steel products of circular cross-section, including oil well casing and tubing, of iron (other than cast iron) or steel (both carbon and alloy), whether seamless or welded, regardless of end finish (*e.g.*, whether or not plain end, threaded, or threaded and coupled) whether or not conforming to American Petroleum Institute (API) or non-API specifications, whether finished (including limited service OCTG products) or unfinished (including green tubes and limited service OCTG products), whether or not thread protectors are attached. The scope of this investigation also covers OCTG coupling stock.
- Excluded from the scope of this investigation is casing or tubing containing 10.5 percent or more by weight of chromium, drill pipe, unattached couplings and unattached thread protectors.

While the HTSUS subheadings are provided for convenience and customs purposes, Commerce's written description of the subject merchandise governs the scope of this investigation.
- From 2006 to 2008, imports of OCTG from China increased 357.67 percent by volume and were valued at an estimated \$2.7 billion in 2008.

## NEXT STEPS

- The U.S. International Trade Commission (ITC) is currently scheduled to issue its final determination on or before January 7, 2010.
- If the ITC makes an affirmative final determination that imports of OCTG from China materially injure, or threaten material injury to, the domestic industry, Commerce will issue a CVD order.
