

## Setting Up an Account in TreasuryDirect


## To set up an account in TreasuryDirect, follow these steps:

- Open your Internet browser (for example, Internet Explorer) and type www.treasurydirect.gov in the address window.
- On the TreasuryDirect home page, under the "Open an Account" section, select "TreasuryDirect."
  - Read the three steps on the "Open an Account" page.

- To open an Individual TreasuryDirect account, make sure you have these things:
  - A taxpayer identification number or a Social Security number.
  - A United States address of record.
  - A checking or savings account.
    - You'll need to know your account and routing numbers.
  - An e-mail address.
    - E.g., YourName@abc.com
  - A web browser that supports 128-bit encryption.
    - The site is optimized for Internet Explorer.
