## **Comments:**

## Graded Agency:

In FY10, NSF demonstrated significant strides in our small business achievement resulting in a two grade improvement from "F" to "C" from FY09. We made a small improvement in our Prime Contracting Achievement and a significant improvement in our Sub Contracting Achievement scores. Our Plan Progress score remains at a perfect 100, a clear indication that NSF is taking steps to improve. NSF exceeds or is within 3 percentage points of 3 of the 5 Prime Contracting Achievement areas. We are focused on improving our areas of weakness, HUBZone and Service Disabled Veteran Small Business, through targeting efforts, as detailed in the Small Business Scorecard progress report. NSF will continue to make every effort to ensure that all small business fully participate in our contracting/subcontracting activities and actively reach out to the small business community by providing counseling services and networking opportunities. NSF's primary obstacle to achieving a high percentage level of Prime Contracting Achievement is that 34% of our FY 2010 small business for Arctic Research Support and Logistics Services, and Ocean Drilling Program Support. Due to the size, complexity and uniqueness of these NSF requirements, a small business is not capable of performing as the prime on any of these contracts.

## SBA:

The National Science Foundation (NSF) met 1 of its 5 prime contracting goals: Small Disadvantaged Business. However, it did not meet its prime contracting goals for Small Business, Woman Owned Small Business, Service-Disabled Veteran Owned Small Business and HUBZone.

Fiscal year 2010 prime contracting achievement saw increases over FY2009 in Women Owned Small Business and Service-Disabled Veteran Owned Small Business. NSF FY2010 achievement declined for Small Business, Small Disadvantaged Business and HUBZone.

NSF occasionally attends Small Business Procurement Advisory Council meetings.
