Comments:

Graded Agency:

In FY 2009, NSF obligated slightly under \$490M for contract actions. Of that amount, \$312.6M or 80% was devoted to 4 large dollar complex contracts with large businesses for Antarctic Support, Arctic Research Support and Logistics Services, and Ocean Drilling Program Support. Due to the size, complexity and uniqueness of these NSF requirements, a small business is not capable of performing as the prime on any of these contracts. As a result, NSF only had 20% of its obligations to possibly award to small business in FY 2009. Undeterred by this situation, NSF was still able to achieve a small business rate of 16.8% in FY 2009.

SBA:

<u>Goaling Achievement</u>
The National Science Foundation (NSF) met 1 of their 5 prime contracting goals missing Small Business, Women Owned Small Business, Service-Disabled Veteran Owned Small Business, and

Fiscal year 2009 prime contracting achievement saw increases over FY2008 in Small Business, Women Owned Small Business, Service-Disabled Veteran Owned Small Business and HUBZone. NSF FY2009 achievement declined from FY2008 in Small Disadvantaged Business.

NSF responded on-time to SBA's contracting data anomaly report and fully addressed submitted anomalies.

Partnership with SBA

NSF rarely attended the SBA chaired Small Business Procurement Advisory Council meetings hosted at the SBA.

Since enactment of ARRA, NSF has directed 0.00% (zero) of their Recovery Act funds toward small businesses.
