BALDINO HAS VIOLATED A COMMISSION ORDER

On May 11, 2004, the Commission instituted an administrative and 5 4 cease-and-desist proceeding against Silverado and Baldino for violations of 6 statutes and rules under the Exchange Act applicable to registered transfer agents. 7 In the Matter of Silverado Stock Transfer, Inc. And Shannon L. Baldino, 8 9 Administrative Proceeding File No. 3-11484. The Commission simultaneously 10 accepted the settlement offer of Silverado and Baldino, and issued an order that, among other things, required Baldino to pay a \$25,000 civil penalty to the United 11 States Treasury within 180 days (by November 9, 2004) (the "Commission 12 Order"). Baldino has failed to pay any of the penalty. 13

CLAIM FOR RELIEF

VIOLATION OF COMMISSION ADMINISTRATIVE ORDER

5. Paragraphs 1 through 4 are realleged and incorporated herein by reference.

18 6. Baldino's failure to pay the \$25,000 civil penalty violated the19 Commission Order.

7. By reason of the foregoing, Baldino violated, and unless enjoined, will continue to violate the terms of the Commission Order, which is enforceable by this Court pursuant to Section 21(e) of the Exchange Act, 15 U.S.C. § 78u(e).

PRAYER FOR RELIEF

WHEREFORE, the Commission respectfully requests that the Court:

I.

Issue findings of fact and conclusions of law that Baldino violated the Commission Order as alleged above.

II.

Issue an Order, pursuant to Section 21(e) of the Exchange Act, 15 U.S.C. § 78u(e), requiring Baldino to comply with the Commission Order.

III.

Retain jurisdiction of this action in accordance with the principles of equity and the Federal Rules of Civil Procedure in order to implement and carry out the terms of all orders and decrees that may be entered, or to entertain any suitable application or motion for additional relief within the jurisdiction of this Court.

IV.

Grant such other and further relief as this Court may determine to be just and necessary.
