## Suspension of Munitions Export Licenses to Halti

AGENCY: Department of Stale ACTION: Notice.

SUMMARY: Notice is hereby given that all licenses and approvals to export or otherwise transfer defense articles and defense services to Haiti, including those for use by the police, pursuant to section 38 of the Arms Export Control Act are suspended until further nonce EFFECTIVE DATE October 3, 1991.

**SUPPLEMENTARY INFORMATION: On** September 30, 1991, *a* coup occurred in Haih ousting the democratically elected President, Fr. Jean-Bertrand Ansude On October 3, the Organization of American States (OSA) adopted a Resolution calling for the suspension of all "military, pohce, or security assistance of any kind and to prevent the delivery of arms, munitions or equipment to that country in any manner, public or pnvate "The OAS also encouraged other states to follow suit

Consistent with the provisions of the OAS Resolution which took effect immediately, it is the policy of the US Government to deny **all** applications for licenses and other approvals to export or otherwise transfer defense articles and services to Haih. including those for use by the police. until further notice In addition, **U**S manufacturers and any other affected parties are hereby notified that the Department **d** Stale has suspended all previously issues licenses and approvals authorizing the export of or other transfers of defense articles or services, as well as those for use by the police. to Haiti On September 30.1991. Foreign Military Financing (FMF) und International Military Education and Training (IMET) funds to Hatti were also suspended until further nonce

The licenses and approvals the the been suspended include manufacturing licenses, technical assistance agreements, technical data, and commercial military exports of any kind subject to the Arms Export Control Act involving Haiti This action also precludes the use in connection with Haiti of any exemptions from licensing or other approval requirements included in the International Traffic in Arms Regulations (ITAR) (22 CFR parts 120-130) until further nonce

In accordance with established policy and procedures, exceptions to this policy will be considered on a case-bycase basis

This action has been taken pursuant to sections 38 and 42 of the Arms Export Control Act (22 US C2778, 2791) and section 1267 of the ITAR in furtherance of the foreign policy of the United States.
