OVW Education, Training and Enhanced Services to End Violence Against and Abuse of Women with Disabilities Grant Program (CFDA 16.529)

Overview

The Office on Violence Against Women (OVW) is a component of the United States Department of Justice (DOJ). Created in 1995, OVW implements the Violence Against Women Act (VAWA) and subsequent legislation and provides national leadership on issues of sexual assault, domestic violence, dating violence, and stalking. Since its inception, OVW has supported a multifaceted approach to responding to these crimes through implementation of grant programs authorized by VAWA. By forging state, local and tribal partnerships among police, prosecutors, judges, victim advocates, health care providers, faith leaders, and others, OVW grants help provide victims with the protection and services they need to pursue safe and healthy lives, while improving communities' capacity to hold offenders accountable for their crimes.

About the OVW Education, Training and Enhanced Services to End Violence Against and Abuse of Women with Disabilities Grant Program

Recognizing the pressing need to focus on sexual assault, domestic violence, dating violence, and stalking against individuals with disabilities and Deaf individuals due to the proliferation of such crimes, Congress authorized the Education, Training and Enhanced Services to End Violence Against and Abuse of Women with Disabilities Grant Program (Disability Grant Program) in the Violence Against Women and the Department of Justice Reauthorization Act of 2005. The goal of the Disability Grant Program is to create sustainable change within and between organizations that result in accessible, safe and effective services for individuals with disabilities and Deaf individuals who are victims of sexual assault, domestic violence, dating violence, and stalking and accountability for perpetrators of such crimes. Disability Grant Program funds will be used to establish and strengthen multidisciplinary collaborative relationships; increase organizational capacity to provide accessible, safe, and effective services to individuals with disabilities and Deaf individuals who are victims of violence and abuse; and identify needs within the grantee's organization and/or service area, and develop a plan to address those identified needs that builds a strong foundation for future work.

Deadlines

Application

All applications will be submitted electronically. The deadline for submitting applications in response to this grant announcement is **11:59 p.m. E.T.** on **February 26, 2013**. Applications submitted after **11:59 p.m. E.T. on February 26, 2013** will <u>not</u> be considered for funding. Applicants experiencing difficulties submitting an application should refer to the Experiencing Unforeseen Technical Issues section on page 14 of this solicitation.

Failure to begin the registration or application submission process in sufficient time is not a suitable reason for a late application submission. It is important that applicants do not wait until the day of the application deadline to submit applications. To ensure a successful application submission, OVW strongly encourages applicants to submit their applications at least a minimum 6 hours before the deadline.

Note: For applicants without Internet access, who cannot submit an application electronically, please contact the Disability Grant Program Specialist at (202) 307-6026 no later than **February 12, 2013** to request permission to submit an application by alternative means.

Registration

Applicants for Federal grants and cooperative agreements are required to have a Data Universal Number System (DUNS) Number to submit an application. A DUNS Number is a unique nine-character identification number provided by the commercial company **Dun & Bradstreet (D&B)**. Once you have completed the D&B registration, your DUNS Number should be available the next business day.

A new Fiscal Year (FY) 2013 requirement for registering with Grants.gov is that your organization must register with the System for Award Management (SAM). Please note that applicants formerly used the Central Contractor Registration (CCR) database for this purpose. SAM is a government-wide registry for vendors doing business with the federal government which requires annual renewal. The SAM centralizes information about grant recipients and also provides a central location for grant recipients to change organizational information. Grants.gov uses SAM to establish roles and IDs for electronic grant applicants.

Applicants must be registered and current with the SAM registration and with Grants.gov prior to submitting an application. Applicants should begin the process immediately to meet the Grants.gov registration deadline, especially if this is the first time using these systems. It is strongly recommended that applicants register by **February 12, 2013** in order to ensure that the registration process is completed and any difficulties are resolved well in advance of the application deadline. Pre-Application Conference Calls

OVW will conduct a total of four Pre-Application Conference Calls. Three calls will be for New Applicants and one call will be for Continuation Applicants. During these calls, OVW staff will review the Disability Grant Program requirements, review the solicitation, and allow for a brief question and answer session. Participation in these calls is optional.

Anyone who is interested in submitting an application to the Disability Grant Program may register to participate in the calls. The total number of participants for each call is limited to 30 individuals.

Eligibility

It is very important that you review this information carefully. Applications that are submitted by ineligible entities or that do not meet all program eligibility requirements will not be considered for funding.

Eligible Entities

Eligible entities for this program are:

- States;
- Units of local Governments;
- Indian Tribal Governments or Tribal organizations; and
- Nonprofit, nongovernmental victim services organizations, such as state domestic violence or sexual assault coalitions, or Tribal domestic violence or sexual assault coalitions or nonprofit, nongovernmental organizations serving individuals with disabilities.

States

For the purposes of this grant program, a state is defined to include all states, the District of Columbia, the Commonwealth of Puerto Rico, the Virgin Islands, American Samoa, Guam, and the Commonwealth of the Northern Mariana Islands.

OVW does not consider public universities as "States" for purposes of eligibility for the Disability Grant Program. However, some universities have affiliated nonprofit organizations that may qualify under the statute. Please contact the Disability Grant Program Specialist at (202) 307-6026 if you need further information regarding this eligibility requirement.

Unit of Local Government

For the purpose of this grant program, a unit of local government is any city, county, township, town, borough, parish, village, or other general-purpose political subdivision of a State; an Indian tribe that performs law enforcement functions as determined by the Secretary of Interior; or, for the purpose of assistance eligibility, any agency of the District of Columbia government or the United States Government performing law enforcement functions in and for the District of Columbia, or any Trust Territory of the United States.

Non-eligible entities generally include, but are not limited to:

- County department or office (Department of Health & Human Services, Office of Health Services);
- Universities (except in cases where the university has an affiliated nonprofit that qualifies under the Disability Grant Program statute.);
- Police departments;
- Sheriff's departments; and
- District or city attorneys' offices.

The above non-eligible entities are typically not units of local government for the purposes of this grant program unless they meet the definition of "unit of local government" set forth in 42 U.S.C. § 3791. Applications from typically "non-eligible" entities that want to assert "unit of local government" status under 42 U.S.C. § 3791 must include in their application proof of such status. If these agencies or organizations do not meet the definition of "unit of local government", they are not eligible to apply directly for funding, but may assume responsibility for the development and implementation of the project. They must apply, however, through a State; a State, local, Territorial or Tribal court; an Indian Tribal government; or a unit of local government.

Indian Tribal Government

For the purposes of this program, Indian Tribal government is defined as the governing body of an Indian Tribe.

Indian Tribe

For purposes of this program, Indian Tribe is defined as a Tribe, band, pueblo, nation, or other organized group or community of Indians, including any Alaska Native village or regional or village corporation (as defined in, or established pursuant to, the Alaska Native Claims Settlement Act (43 U.S.C. 1601 et seq.)), that is recognized as eligible for the special programs and services provided by the United States to Indians because of their status as Indians (42 U.S.C. 13925 (a)(30).

Tribal Organization

For the purposes of this program, Tribal organization is defined as the governing body of any Indian Tribe; any legally established organization of Indians which is controlled, sanctioned, or chartered by such governing body of a Tribe or Tribes to be served, or which is democratically elected by the adult members of the Indian community to be served by such organization and which includes the maximum participation of Indians in all phases of its activities; or any Tribal nonprofit organization. (42 U.S.C. 13925 (a) (32)).

Any applicant representing a consortium of Tribal governments and/or organizations must submit a resolution or legal equivalent from the constituent Tribal governments and/or organizations supporting the application¹.

¹ Regarding a Tribal consortium application, the applicant must submit documentation of authority as described above from each Tribal consortium member, unless existing consortium bylaws or other tribal governance documents allow action without explicit authorization from the member Tribes in the consortium. In that case, the Tribal consortium must submit a resolution, a letter, affidavit, or other documentation, as appropriate, that certifies that the Tribal consortium has the legal authority to apply for grants on behalf of the consortium. **This documentation must be current, sufficient to demonstrate authority for the application, contain authorizing signature(s), and submitted by the application's due date.** In addition, a copy of the bylaws or other governance documents that allow the Tribal consortium's action without support from all consortium members must be included with this documentation.

Victim Services Organization

For the purposes of this program, nonprofit and nongovernmental victim services organizations will be considered eligible only if they provide direct victim services; have demonstrated experience in serving individuals with disabilities or demonstrated experience in addressing sexual assault, domestic violence, dating violence, and stalking

Program Eligibility Requirements

In addition to meeting the eligible entity requirements outlined above, applications for the Disability Grant Program must also meet the requirements below. All certification and other eligibility related documents must be current and developed in accordance with the FY 2013 application.

Multidisciplinary Collaborative Team

Every applicant must identify and support, as evidenced in the Memorandum of Understanding, a multidisciplinary collaborative team comprised of, at a minimum, the following:

- At least one nonprofit, nongovernmental victim services organization or Tribal organization serving victims, such as a state or Tribal domestic violence or sexual assault coalition; **and**
- At least one nonprofit, nongovernmental organization or Tribal organization serving individuals with disabilities.

Furthermore, every applicant must identify whether the multidisciplinary collaborative team will have a state focus or a local focus. Under the Disability Grant Program, state or local focused projects are defined as follows:

- A state focused project is a multidisciplinary collaborative team comprised **solely** of
 organizations that operate at a state level (e.g., state independent living council, state or
 Tribal sexual assault and/or domestic violence coalition). A state focused project will
 concentrate efforts in either <u>one to two communities within the State</u>, or the organizations
 that operate at a state level themselves will be the focus of grant activities.
- A local focused project is a multidisciplinary collaborative team comprised **solely** of local or community based organizations (e.g., center for independent living, community mental health, rape crisis center, or domestic violence shelter/program). Grant activities will focus within and between the local or community based organizations represented on the multidisciplinary collaborative team.

Please note, applications that propose multidisciplinary collaborative teams that do not meet the requirements outlined above will not be considered for funding. Furthermore, applications that propose activities covering an entire State, multiple States, regional, or nation-wide activities will not be considered for funding.

Types of Applicants

In FY2013, OVW will accept applications for the Disability Grant Program from the following:

<u>New:</u> applicants who have never received funding under the Disability Grant Program or who received funding prior to FY 2006.

<u>Continuation:</u> applicants who received funding under the Disability Grant Program after FY 2006. Continuation funding is not guaranteed.

Grant recipients who received new funding for 36 months in FY 2011 or FY 2012 or continuation funding for 24 months in FY 2012 are NOT eligible to apply.

Applicants funded in FY 2009 or FY 2010 that have not completed a significant portion of implementation phase activities, or who have a substantial amount of remaining funds at the time of application submission, will not be considered for funding in FY 2013.

Award Information

Applicants that receive an award are bound by the provisions of this solicitation, the OVW Financial Grants Management Guide, and any updates to the Guide, and any conditions of the recipients' award.

Availability of Funds

All awards are subject to the availability of appropriated funds and any modifications or additional requirements that may be imposed by law. There is no guarantee that funds will be available in the future. Therefore, OVW encourages applicants to develop a plan to sustain project activities if Federal funding through the Disability Grant Program were no longer available.

Cooperative Agreement

Applicants should be aware that awards will be made as cooperative agreements, and OVW will play a substantial role in shaping and monitoring the project.

Award Period

The grant award period is 36 months for new applicants and 24 months for continuation applicants. Budgets must reflect 36 or 24 months of project activity, and the total "estimated funding" (block 15) on the SF-424 must reflect 36 or 24 months.

Award Amounts

Applicants should carefully consider the resources needed to successfully implement the proposed project and present a realistic budget that accurately reflects project costs.

OVW has the discretion to award grants for greater or lesser amounts than requested and to negotiate the scope of work and budget with applicants prior to award of a grant.

Funding levels under the Disability Grant Program for FY 2013 are as follows:

- New, local-focused project \$500,000
- New, state-focused project \$600,000
- Continuation, local-focused \$400,000
- Continuation, state-focused \$450,000

Program Scope

Activities supported by the Disability Grant Program are determined by statute, Federal Regulations, and OVW policies. If an applicant receives an award, the funded project is bound by the provisions of this solicitation, the OVW Financial Guide, and the conditions of the recipient's award.

Purpose Areas

In FY 2013, funds under the Disability grant Program may be used for the following purposes:

- To provide personnel, training, technical assistance, advocacy, intervention, risk reduction and prevention of sexual assault, domestic violence, dating violence, and stalking against individuals with disabilities;
- To conduct outreach activities to ensure that individuals with disabilities who are victims of sexual assault, domestic violence, dating violence, and stalking receive appropriate assistance;
- To conduct cross-training for victim service organizations, governmental agencies, courts, law enforcement, and nonprofit, nongovernmental organizations serving individuals with disabilities about risk reduction, intervention, prevention and the nature of sexual assault, domestic violence, dating violence, and stalking for individuals with disabilities;
- To provide technical assistance to assist with modifications to existing policies, protocols, and procedures to ensure equal access to the services, programs, and activities of victim service organizations for individuals with disabilities;
- To provide training and technical assistance on the requirements of shelters and victim services organizations under Federal anti-discrimination laws, including the Americans with Disabilities Act of 1990 and section 794 of title 29 (Section 504 of the Rehabilitation Act of 1973);
- To modify facilities, purchase equipment, and provide personnel so that shelters and victim service organizations can accommodate the needs of individuals with disabilities;
- To provide advocacy and intervention services for individuals with disabilities who are victims of sexual assault, domestic violence, dating violence, and stalking; or
- To develop model programs providing advocacy and intervention services within organizations serving individuals with disabilities who are victims of sexual assault, domestic violence, dating violence, or stalking.

Mandatory Program Requirements: New Applicants

An applicant who fails to include these requirements in its application, and is chosen for funding, will be required to incorporate all of these activities into their project.

Planning & Development and Implementation Phases

OVW mandates that new grantees engage in an intensive, structured process, which includes a planning and development phase and an implementation phase. Project activities during the planning and development phase have been predetermined. Implementation phase initiatives and activities will be identified in the strategic plan drafted during the planning and development phase and will directly respond to the needs identified in the needs assessment.

New grantees must work closely with OVW and the designated technical assistance provider (TA provider) during the mandatory planning and development phase. The program planning requirements during this phase of the project include the development of the following materials:

- Collaboration charter;
- Project focus memo;
- Needs assessment plan and tools;
- Needs assessment report; and
- Strategic plan.

Technical Assistance

Technical assistance (TA) under the Disability Grant Program is proactive and required. Multidisciplinary collaborative teams must participate in all technical assistance events supported by OVW related to the Disability Grant Program. TA will be delivered through, but not limited to: frequent, regular contact with the OVW identified TA provider, site visits, tele/video conference calls, grantee meetings and Web-based technical assistance. New grantees should expect a high level of involvement with the OVW identified TA provider for the duration of the cooperative agreement.

Decision-Maker Participation

The Executive Director, CFO/CEO, Board of Directors and other decision-makers from all organizations involved with the project must be involved in an active and meaningful manner throughout the life of the project. They should expect to attend meetings and engage in conversations at various points in time. They should also be prepared to implement systemic changes within the organization to improve services and responses to individuals with disabilities and Deaf individuals who have experienced violence and abuse.

Mandatory Program Requirements: Continuation Applicants

An applicant who fails to include these requirements in its application, and is chosen for funding, will be required to incorporate all of these activities into their project.

Scope of Activities

Continuation applicants must propose projects that will either enhance the previously funded project or replicate the previously funded project in a different community. Specifically, proposed activities must build upon the successful initiatives funded during the previous project.

Critical Assessment

Continuation grantees will be required to reevaluate proposed activities to ensure that they enhance and build upon initiatives funded during the previous project. This review will take place within six months of the project start date.

Purpose Areas

Continuation applicants must propose projects that address at least one of the eight Disability Grant Program Purpose Areas (page 9) specified in this solicitation. If an applicant proposes to utilize grant funds to support direct services, an overall coordinated response to sexual assault, domestic violence, dating violence, and stalking against individuals with disabilities and/or Deaf individuals must also be included. Applicants may not propose to engage solely in providing direct services.

OVW Priority Areas

OVW encourages applications that propose activities in the following areas:

Sexual Assault

OVW recognizes that sexual assault against individuals with disabilities and Deaf individuals is a serious problem. As such, OVW is encouraging applicants to submit proposals that address sexual assault and include a sexual assault victim services organization as a mandatory member of the multidisciplinary collaborative team. This program defines a sexual assault victim services organization as a state sexual assault coalition, rape crisis center, or a victim services program that has a demonstrated history of providing appropriate services to rape and sexual assault victims.

Underserved Populations

OVW recognizes that victims with disabilities and Deaf victims from underserved populations frequently confront unique challenges when seeking assistance. As such, OVW is encouraging applicants to submit proposals that increase support for underserved populations, particularly communities of color, in a culturally appropriate manner, with a special emphasis on African-American, tribal and LGBT communities.

Activities that Compromise Victim Safety and Recovery

The following activities have been found to jeopardize victim safety, deter or prevent physical or emotional healing for victims, or allow offenders to escape responsibility for their actions:

- Procedures or policies that exclude victims from receiving safe shelter, advocacy services, counseling, and other assistance based on their actual or perceived age, immigration status, race, religion, sexual orientation, gender identity, mental health condition, physical health condition, criminal record, work in the sex industry, or the age and/or gender of their children;
- Procedures or policies that compromise the confidentiality of information and privacy of persons receiving OVW-funded services;
- Activities that focus on victim services programs only and do not address issues of trauma informed practice within disability organizations;
- Establishment of a multidisciplinary collaborative team without developing policies regarding confidentiality and information sharing for the team members;
- Policies that deny individuals access to services because of a disability; and
- Safety plans that do not adequately address the unique needs of individuals with disabilities and/or Deaf individuals.

Applications that propose activities that compromise victim safety and recovery may receive a deduction in points during the review process or may be eliminated from further consideration entirely.

Out-of-Scope Activities

OVW has determined the activities listed below to be out of the program scope. Applications that propose out-of-scope activities may receive a point deduction during the review process. Applications that are determined to be substantially outside the scope of the Disability Grant Program will not be considered for funding. The following activities are out of scope and will not be supported by Disability Grant Program funding:

- Research projects (This does not include program assessments conducted only for internal improvement purposes. See section on Research and Protection of Human Subjects in the FY 2013 Solicitation Companion Guide at <u>http://www.ovw.usdoj.gov/docs/companionguide-10-16-12.pdf;</u>
- Public service campaigns; and
- Projects that specifically focus on children.

Unallowable Activities

The following is a list of activities that are unallowable and cannot be supported by Disability Grant Program funding. Applications that propose unallowable activities may receive a point deduction during the review process. Applications that include substantial unallowable activities will not be considered for funding.

- Lobbying
- Fundraising
- Purchase of real property
- Construction
- Physical modifications that have not been approved by OVW and/or that are in excess of 2% of the total award.*

*Applicants proposing to use grant funds for physical modifications must follow the guidelines set forth in Appendix B - Physical Modification Guidelines.

How To Apply

This section describes how an application should be submitted. Applicants should anticipate that failure to meet all registration and submission deadlines will result in their application being removed from consideration. It is the responsibility of the applicant to ensure that the application is submitted by the deadline.

Application Registration Requirements

It is very important that all applicants read this section carefully. Applicants that do not complete all the steps in registering and submitting their application by the due date will not be considered for funding. Applicants are responsible for ensuring their applications are complete at the time of submission. OVW will not contact applicants for missing items.

Each applicant must obtain a Data Universal Numbering System (DUNS) number, be registered in the System for Award Management (SAM) and submit their application online via either Grants.gov or the Grants Management System (GMS) according to the instructions. Applicants are encouraged to submit their applications well in advance (a minimum of 6 hours) of the deadline to allow sufficient time to address technical problems. Applicants should ensure that the DUNS number for the application is for an organization that is eligible to apply for the grant program. Also, only the organization that is registered in SAM may use that DUNS number and Grants.gov registration to submit an application.

System for Award Management (SAM)

Applicants for all federal grants are required to register with the System for Award Management (SAM). If your organization already has an Employer Identification Number (EIN), your SAM registration will take up to two weeks to process. If your organization does not have an EIN, then you should allow two to five weeks for obtaining the information from IRS when requesting the EIN via phone, fax, mail or Internet. Follow the steps listed below to register in the SAM:

Step 1: Obtain a DUNS number at the following website <u>http://www.dnb.com/us/</u> or call (866) 705-5711.

Step 2: Access the SAM online registration through the SAM home page at <u>https://www.sam.gov/</u> and follow the online instructions for new SAM users.

Step 3: Complete and submit the online registration. If you already have the necessary information on hand, the online registration takes approximately 30 minutes to complete, depending upon the size and complexity of your business or organization. Once your SAM registration becomes active, you will be able to return to Grants.gov and complete the registration. **Please note that**

organizations must update or renew their SAM registration at least once a year to maintain an active status. (Applicants formerly used the Central Contractor Registration (CCR) database).

Grants.Gov

After you obtain your DUNS number and register with SAM, you can begin the Grants.Gov registration process. In order to apply for a grant your organization must complete the Grants.gov registration process <u>prior to beginning an application for a federal grant</u>. Complete instructions can be found at <u>Grants.gov</u>. The registration process can take between three and five business days or as long as four weeks if all steps are not completed in a timely manner. Please note that Grants.gov is <u>not</u> the Office of Justice Programs' (OJP) Grants Management System (GMS) through which OVW discretionary program applicants have submitted applications in previous years. If applicants experience difficulties at any point during this process, they may call the Grants.gov Customer Support Hotline at 1-800-518-4726.

Note: Grants.gov will forward the application to OJP's Grants Management System (GMS). GMS does not accept executable file types as application attachments. These disallowed file types include, but are not limited to, the following extensions: ".com," ".bat," ".exe," ".vbs," ".cfg," ".dat," ".db," ".dbf," ".dll," ".ini," ".log," ".ora," ".sys," and ".zip."

For guidance on using the Grants.gov system, please go to the following page <u>http://www.grants.gov/applicants/app_help_reso.jsp</u> which includes Frequently Asked Questions and User Guides that will assist you with using Grants.gov. We strongly recommend reviewing the Grants.gov guidance since that will be the most up-to-date information related to Grants.gov.

Applicants without Internet Access

For applicants without Internet access, who cannot submit an application electronically, please contact the Disability Grant Program Specialist at (202) 307-6026 no later than **February 12, 2013** to request permission to submit an application by alternative means.

OVW Policy on Late Submissions

OVW offers several options for applicants to provide advance notice to OVW if receipt of their application will be delayed due to a temporary lack of Internet access, other technical difficulties, or geographic isolation. If applicants do not provide advance notice to OVW about an issue that may cause a delay in the submission of the application, then the application will not be considered for funding. If applicants follow the steps outlined below, late submission may be considered. Extension of deadlines is not guaranteed.

Experiencing Unforeseen Technical Issues

Applicants are advised to attempt to submit the application well in advance of the 11:59 p.m. E.T. deadline. If you experience technical difficulties at any point during the application process, please contact the Grants.gov Customer Support Hotline at 1-800-518-4726, or <u>support@grants.gov</u>, 24 hours a day, 7 days a week, except closed for federal holidays.

If you experience unforeseen technical issues that prevent you from submitting your application by the deadline, you must take the following actions:

- contact the Disability Grant Program Specialist at (202) 307-6026 or at <u>OVW.Disabilities@usdoj.gov</u> prior to the application deadline stating that you are experiencing unforeseen technical issues; and
- contact the technical support number above prior to deadline.

Within 24 hours after the deadline you must again contact the Disability Grant Program Specialist at (202) 307-6026 or at <u>OVW.Disabilities@usdoj.gov</u> to request approval to submit your application. At that time, you will be required to email the complete grant application, your DUNS number, and provide a Grants.gov Help Desk tracking number(s). After OVW reviews all of the information submitted and verifies your technical issues with the Helpdesk, OVW will contact you to either approve or deny your request to submit a late application. If the technical issues you reported cannot be verified, your application will be rejected as untimely.

To ensure a fair competition for limited discretionary funds, the following conditions are <u>not</u> valid reasons to permit late submissions: (1) failure to begin the registration process in sufficient time; (2) failure to register or update information on the SAM website; (3) failure to follow GMS or Grants.gov instructions as posted on its website; and (4) failure to follow all of the instructions in the OVW solicitation.

Extraordinary Natural or Manmade Disasters

In cases of extraordinary natural or manmade disasters, such as extreme weather emergencies or terrorist acts, applicants may request to submit applications up to seven calendar days late, by sending an e-mail to the contact listed in the solicitation. The message should specify the nature of the disaster and how it affected the applicant's ability to submit an application on time.

Application Contents

This section describes what is included in a complete application package. Applicants should anticipate that failure to submit an application that contains all of the specified elements will negatively affect the review of the application and may result in the application not being considered for funding; should a decision be made to make an award, it may result in the inclusion of special conditions that preclude access to or use of award funds pending satisfaction of the conditions. It is the responsibility of the applicant to ensure that a complete application is submitted by the deadline.

Formatting and Technical Requirements

Applications must follow the requirements below. Points may be deducted for applications that do not adhere to the following requirements:

- Double spaced (Project Abstract, Summary Data Sheet and charts may be single space)
- 81/2 x 11 inch paper
- One-inch margins
- Type no smaller than 12 point, Times New Roman font
- Page numbers
- No more than 20 pages for the Project Narrative
- Word processing documents must be in the following formats: Microsoft Word (.doc), PDF files (.pdf), or Text Documents (.txt).
- Headings and sub-headings that correspond to the sections identified in the Application Contents section of this solicitation.

Application Requirements

Applications must include the following required documents and demonstrate that the program eligibility requirements have been met. Applications that do not address any of the following components will be considered substantially incomplete and will not be considered for funding:

- 1. Project Narrative
- 2. Budget Detail Worksheet and Narrative
- 3. Memorandum of Understanding outlining the Multidisciplinary Collaborative Team requirements

In addition to the application being scored on the documents listed above, the Summary Data Sheet will also be scored.

Summary Data Sheet (5 Points)

The Summary Data Sheet should be one to four pages in length and may be single or double spaced. The Summary Data Sheet does not count toward the 20 page limit for the Project Narrative. Please provide the following information:

- Name, title, address, phone number, and e-mail address for the authorized representative (see page 23, SF 424 for the definition of the authorized representative).
- Name, title, address, phone number, and e-mail address for the grant point-of-contact.
- Statement as to whether the agency applying has expended \$500,000 in Federal funds in the past fiscal year of the applicant. Please specify the end date of the applicant's fiscal year.
- A list of other Federal grant programs from what the applicant organization currently receives funding or for which it has applied in Federal Fiscal Year 2013 to do similar work.
- Whether it is a new or continuation application.
- Geographic focus (state or local).
- Disability focus (general, or a specific type of disability).
- Crime focus (sexual assault, domestic violence, or both).
- List of multidisciplinary collaborative team members. Specify if the organization is a sexual assault, domestic violence, dual or a disability organization.
- The percentage of grant activities, should the application be funded, that will address each of the following issues:
 - Sexual assault;
 - o Domestic violence;
 - o Dating/teen dating violence; and/or
 - o Stalking.
- Summary of Current and Recent OVW Projects (if applicable)
 - If the applicant has a current grant award or cooperative agreement under any OVW program, or received an award that has been closed within one calendar year, the information below must be included.
 - Identify all grants by OVW program, award number, and project period.
 - Specify the total funding amount for each grant (initial and supplemental amounts, if applicable).
 - Specify the total funds remaining in each grant as of the date of application.
 - Provide the total funds remaining in each budget category (Personnel, Fringe, Travel, Equipment, Supplies, Construction, Contractual, and Other) for each grant.
 - Provide justification for remaining funds.
 - Estimate the amount of grant funds that will be remaining at the end of the current project period.
 - List the number and titles of all full-time and/or part-time positions funded by the award.

Continuation applicants who have a substantial amount of remaining funds at the time of application submission without adequate justification may not be considered for funding in FY 2013.

Project Narrative: New Applicants (65 Points Total)

The Project Narrative may not exceed 20 pages in length, double-spaced. The Project Narrative comprises the following two sections:

Purpose of Application (35 Points)

This section must include:

- The service area (state or local service area) in which the project will be implemented;
- Demographic information, as it relates to individuals with disabilities and/or Deaf individuals in the service area;
- Type of disability the project will focus on (may be disability in general or a specific type of disability) and the rationale for the focus;
- The current response to violence against individuals with disabilities and/or Deaf individuals within the proposed service area as it relates to the disability focus;
- Current gaps and barriers to providing services to individuals with disabilities and/or Deaf
 individuals who are victims of violence and abuse in the service area as it relates to the
 disability focus;
- Challenges that the organizations that comprise the multidisciplinary collaborative team have experienced in providing services to individuals with disabilities and/or Deaf individuals who are victims of violence and abuse as it relates to the disability focus; and
- The need for project resources and how funding would alleviate that need. The need must directly relate to the stated gaps and barriers to providing services to individuals with disabilities and/or Deaf individuals who are victims of violence and abuse in the service area.

Who Will Implement the Project (30 Points)

This section must include the information below. In doing so, the applicant must justify who will be involved in the project and demonstrate that they have the capacity to address the stated need and that they can successfully implement Disability Grant Program requirements.

- Provide detailed information about the organizations and individuals that comprise the multidisciplinary collaborative team. Multidisciplinary collaborative team members must be related directly to the stated need and service area;
- Clearly demonstrate that the multidisciplinary collaborative team requirements, as required by the solicitation, have been met;
- Describe in detail why each multidisciplinary collaborative team member was chosen. In doing so, the application must demonstrate a direct relationship to the stated need and detail the qualifications and capacity of each multidisciplinary collaborative team member (organizations and individuals) to achieve the project goals;
- Describe the resources and skills each multidisciplinary collaborative team member will bring to the project;
- Identify the constituents of each multidisciplinary collaborative team member. The applicant
 must detail the services each multidisciplinary collaborative team member provides for their
 respective constituents; and
- Detail the ability of each multidisciplinary collaborative team member to create change. The applicant must address the ability of each multidisciplinary collaborative team member to

create change within their own organization and, if applicable, among their member programs and affiliated groups. Examples must be provided.

Project Narrative: Continuation Applicants (65 Points Total)

The Project Narrative may not exceed 20 pages in length, double-spaced. The Project Narrative is comprised of the following three sections:

Purpose of Application (20 Points)

This section must include:

- The service area (state or local service area) in which the project will be implemented;
- Demographic information, as it relates to individuals with disabilities and/or Deaf individuals in the service area;
- The type of disability the project will focus on (may be disability in general or a specific type of disability) and the rationale for the focus;
- The current response to violence against individuals with disabilities and/or Deaf individuals within the proposed service area as it relates to the disability focus;
- Current gaps and barriers to providing services to individuals with disabilities and/or Deaf
 individuals who are victims of violence and abuse in the service area as it relates to the
 disability focus;
- Challenges that multidisciplinary collaborative team members have experienced in providing services to individuals with disabilities and/or Deaf individuals who are victims of violence and abuse as it relates to the disability focus;
- A description of the diversity within the disability focus. For example, LGBTQ, immigration, or communities of color; and
- The need for project resources and how funding would alleviate that need. The need must directly relate to the stated gaps and barriers to providing services to individuals with disabilities and/or Deaf individuals who are victims of violence and abuse in the service area.

What Will Be Done (25 Points)

This section must include the information below. In doing so, the applicant must provide a clear link between the proposed activities and the need identified in the "Purpose of Application" section.

- Describe in detail what activities the multidisciplinary collaborative team will engage in. Activities must correspond to the stated need;
- Illustrate how the proposed activities and initiatives will build upon and/or enhance previously funded activities;
- Illustrate how the proposed activities are responsive to the diversity within the disability focus, as identified in the Purpose of the Application;
- Describe in detail the responsibilities of each multidisciplinary collaborative team member, as they correspond to the proposed activities;
- Demonstrate the capacity of the multidisciplinary collaborative team to successfully implement project activities; and
- Detail expected outcomes.

Who Will Implement the Project (20 Points)

This section must include the information below. In doing so, the applicant must justify who will be involved in the project and demonstrate that they have the capacity to address the stated need and that they can successfully implement the stated project activities.

- Provide detailed information about the organizations and individuals that comprise the multidisciplinary collaborative team. Multidisciplinary collaborative team members must be related directly to the stated need and service area;
- Clearly demonstrate that the multidisciplinary collaborative team requirements, as required by the solicitation, have been met;
- Describe in detail why each multidisciplinary collaborative team member was chosen. In doing so, the application must demonstrate a direct relationship to the stated need and detail the qualifications and capacity of each multidisciplinary collaborative team member (organizations and individuals) to achieve the project goals;
- Describe the resources and skills each multidisciplinary collaborative team member will bring to the project;
- Identify the constituents of each multidisciplinary collaborative team member organization. The applicant must detail the services each multidisciplinary collaborative team member organization provides for their respective constituents;
- Detail the ability of each multidisciplinary collaborative team member to create change. The applicant must address the ability of each multidisciplinary collaborative team member to create change within their own organization and, if applicable, among their member programs and affiliated groups. Examples must be provided;
- Demonstrate that the multidisciplinary collaborative team represents the diversity within the disability focus, as identified in the Purpose of the Application;
- Describe lessons learned during the previous grant project;
- Detail activities or strategies the multidisciplinary collaborative team will engage in to strengthen the collaborative relationship and work;
- Describe any changes in the multidisciplinary collaborative team membership (addition or exclusion); and
- Provide the reasoning for changing, or not changing, the multidisciplinary collaborative team composition. If adding multidisciplinary collaborative team members, the application must describe a strategy for orienting the new member(s) into the group. The application must describe the benefits and challenges of including a member(s) to the existing collaborative.

Proposal Abstract: New and Continuation Applicants

The Proposal Abstract should provide a short and accurate summary of the proposed project including who will be involved with the proposed project, what will be done as primary activities, what products will be produced, the service area where the proposed project will take place and who will be impacted by the proposed project. Please do not summarize past accomplishments in this section.

Budget Detail Worksheet and Narrative: New and Continuation Applicants (10 Points)

All applicants, except for those applying for formula grant programs, are required to submit a detailed budget and supporting budget narrative. Budgetary requirements vary slightly among programs, and applicants must read the solicitation closely to determine the requirements of the budget and budget narrative for each OVW program.

Award Period and Amount

- New, local-focused project, 36 months, \$500,000
- New, state-focused project, 36 months, \$600,000
- Continuation, local-focused, 24 months, \$400,000
- Continuation, state-focused, 24 months, \$450,000

Budget Requirements

Applicants must submit reasonable budgets based on the resources needed to implement their projects in their specific geographic location. The budget should display a clear link between the specific project activities and the proposed budget items. Specifically, the budget should not contain any items that are not detailed in the project narrative. The budget narrative must support all costs included in the budget and explain how the costs of goods and services are determined and how they will fulfill the overall objective of the project.

Only the STOP Violence Against Women Formula Grant Program requires matching funds. However, applicants to other programs are encouraged to maximize the impact of federal dollars by contributing to the costs of their projects. Supplemental contributions may be cash, in-kind services, or a combination of both. Any non-Federal contributions can be discussed in the project narrative or Memorandum of Understanding (if required). Applicants should not include supplemental contributions in the budget, budget narrative, or SF-424.

In some circumstances, the budget and budget narrative will be reviewed separately from the proposed project narrative. Therefore, it is very important that the budget narrative be as comprehensive as possible and describe in a narrative format each line item requested in the budget.

A Sample Budget Detail Worksheet is available in **Appendix A**. When preparing the Budget Detail Worksheet and Narrative, please use the Sample Budget Detail Worksheet as a guide and be sure to include all necessary budget categories as outlined in the Worksheet. The budget must adhere to the OVW Financial Grants Management Guide, which can be found at http://www.ovw.usdoj.gov/docs/gfmd-financial-grants-management-guide.pdf.

All applicants must:

- Include a line item(s) to pay for necessary accommodations. Accommodations may include, but are not limited to, American Sign Language (ASL) Interpreters, printing in alternative formats, or adaptive equipment; and
- Fairly compensate all project partners.

Federal Financial Guidelines

Federal grants are governed by the provisions of the OMB circulars applicable to financial assistance and the OVW Financial Grants Management Guide, which can be found at http://www.ovw.usdoj.gov/docs/gfmd-financial-grants-management-guide.pdf. The Financial Grants Management Guide includes information on allowable costs, methods of payment, audit requirements, accounting systems, and financial records. This document outlines the successful administration of grant funds.

Any recipient of an award will be responsible for monitoring subgrants/contracts under the grant in accordance with all applicable statutes, regulations, OMB Circulars and guidelines, and the OVW Financial Grants Management Guide. Primary recipients will be responsible for oversight of

subgrantee spending and monitoring specific performance measures and outcomes attributable to the use of OVW funds.

Food and Beverage/Costs for Refreshments and Meals

Generally food and beverage costs are **not** allowable, and under no circumstances may OVW funding be used to supply food and/or beverages during refreshment breaks. OVW may approve the use of OVW funds to provide food and/or beverages for a meal at a meeting, conference, training, or other event, if one of the following applies:

- The location of the event is not in close proximity to food establishments. It should be a priority to try to secure a location near reasonably priced and accessible commercial food establishments.
- Not serving food will significantly lengthen the day or necessitate extending the meeting to achieve meeting outcomes.
- A special presentation at a conference requires a plenary address where there is no other time for food to be obtained.
- Other extenuating circumstances necessitate the provision of food.

Justification for an exception listed above must be included in the budget narrative, and funds may only be used to purchase food and/or beverages for a meal at a meeting, conference, training, or other event if OVW approves the specific expenditures in advance.

Cooperative agreement recipients must seek approval of these costs through the conference approval process. Approval of the budget is not an approval of food and beverage expenditures. For cooperative agreement recipients, food and beverage is not allowed until a conference request approval form has been submitted and approved by OVW.

Conference Planning and Expenditure Limitations

Applicants should be aware of all applicable laws, regulations, policies and guidance (including specific cost limits, prior approval and reporting requirements, where applicable) governing the use of Federal funds for expenses related to conferences (which is defined to include meetings, retreats, seminars, symposiums, training and other similar events), including the provision of food and/or beverages at such events, and costs of attendance at such events. Information on pertinent laws, regulations, policies and guidance is available at

http://www.ovw.usdoj.gov/grantees.html. Applicants should also be aware of the following specific restrictions on conference planning and expenditure limitations:

- Cost of Logistical Conference Planning
- Cost of Programmatic Conference Planning
- Conference Space and Audio-Visual Equipment and Services
- Prohibition on Trinkets at Conferences
- Entertainment at Conferences
- Food and Beverages at Conferences
- Prior Approval Required Before Entering Into Contracts or Expending Funds for Conferences
- Conference Reporting

Updated Department of Justice and OVW guidance on conference planning, minimization of costs, and conference cost reporting is accessible on the OVW website <u>http://www.ovw.usdoj.gov/grantees.html</u>. For additional information regarding food and beverage

regulations, please refer to the OVW Financial Grants Management Guide at <u>http://www.ovw.usdoj.gov/docs/gfmd-financial-grants-management-guide.pdf</u>.

Training and Technical Assistance

All applicants are required to allocate funds in the amount of \$20,000 to support travel costs associated with technical assistance and capacity-building activities sponsored by OVW-designated technical assistance providers. Applicants from Alaska, Hawaii, and United States Territories should allocate \$35,000 to account for higher travel costs. These specific applicants may exceed the budget caps to account for this increased travel amount. The required set-aside amount may be shared between the applicant and any partnering agency(ies), but the budget must reflect the costs in the appropriate categories. Therefore, an employee's travel costs should be included in the "Travel" category, while travel costs for the partner(s) must be included in the "Consultants/Contracts" category. Label both costs as "OVW Technical Assistance." Include an estimated breakdown for these costs, including the number of trips, number of travelers, airfare or mileage, lodging, per diem, etc. (OVW technical assistance is provided free of charge to grantees, so applicants do not need to include registration fees). This amount should equal the full, required set-aside amount listed above.

Please note these funds can **only** be used for OVW designated technical assistance, unless otherwise approved by OVW. Any training and technical assistance funds not used by the end of the grant period may not be reprogrammed and must be returned to OVW. Travel funds should be used to support travel by all project partners including nonprofit, nongovernmental victim service providers. Funds may also be used by persons whose positions are not grant funded as long as that person's roles and responsibilities are linked to the project's overall mission.

Program Evaluations

Applicants may not use any OVW funds to conduct research. However, up to three percent of the budget may be allocated for the purpose of assessing the effectiveness of funded activities. For example, funds may be used to conduct pre- and post-testing of training recipients or for victim satisfaction surveys. In conducting such testing or surveys, grantees may not collect, analyze or disseminate any information that would disclose the identity of an individual.

Accommodations and Language Access

Applicants are encouraged to allocate grant funds to support activities that help to ensure individuals with disabilities and Deaf individuals and persons with limited English proficiency have meaningful and full access to their programs. For example, grant funds can be used to support American Sign Language (ASL) interpreter services, language interpretation and translation services, or the purchase of adaptive equipment.

Applicants proposing to use grant funds to create websites, videos and other materials must ensure that they are accessible to persons with disabilities. Grant funds must be allocated for these purposes.

Memorandum of Understanding (MOU): New and Continuation Applicants (20 Points Total)

For purposes of this application, the MOU is a document containing the terms of the partnership and the roles and responsibilities between two or more parties. The MOU should be a single document and should be signed and dated by the Authorized Representative (see page 23, SF-424 for the definition of the authorized representative) of each proposed partner agency during the development of the application. In rare circumstances, an MOU can include multiple signature pages as long as each page includes the name and title of each signing party. In order to meet the eligibility requirements, the MOU **must** clearly demonstrate that the multidisciplinary collaborative team requirements have been met. Please see the Eligibility section of this solicitation (page 5).

- Clearly identify the multidisciplinary collaborative team members. The MOU must specify if the organization is a sexual assault, domestic violence, dual, or a disability organization;
- Clearly identify if the multidisciplinary collaborative team has a state or a local focus; and
- Clearly illustrate that all multidisciplinary collaboration team members operate at either the state level, or are local or community based organizations.

In addition, the MOU must:

- Provide a brief history of the collaborative relationship among the multidisciplinary collaborative team members, including when and under what circumstances the relationship began and when each team member entered into the relationship;
- Clearly state the roles and responsibilities each multidisciplinary collaborative team member will assume to ensure the success of the proposed project;
- Clearly demonstrate the capacity of each multidisciplinary collaborative team member to fulfill the goals of the proposed project;
- Clearly demonstrate the commitment of each multidisciplinary collaborative team member to work together to achieve stated project goals;
- Clearly detail the resources each multidisciplinary collaborative team member will contribute to the project; and
- Clearly demonstrate the ability and willingness of each multidisciplinary collaborative team member to effect change within their own organization and, if applicable, among their member programs or affiliated groups.

Additional Required Information

The following documents will not be scored during the review process but they should be included with your submission. Failure to include any of the information may result in the inability to access funds if your application is selected for funding.

Application for Federal Assistance (SF-424)

Applicants must complete the SF-424 online. In block 7 (Type of Applicant), please do not select "other." Please pay careful attention to the amount of Federal funding requested in box 15 of this form. This amount must match the amount of Federal funding requested in the budget section of the application package. Only include values in box 16 ("Recipient") if the program solicitation requires a match. The individual who is listed in box 18 must be the Authorized Representative for the applicant agency. The Authorized Representative is an individual who has the authority to apply for and accept grant awards on behalf of the eligible organization or jurisdiction.

Standard Assurances and Certifications Regarding Lobbying; Debarment, Suspension, and Other Responsibility Matters; and Drug-Free Workplace Requirements (Form 4061/6)

Please carefully review the assurances and certification forms online. These forms will be completed online at a later time during the application process.

Letter of Nonsupplanting

Applicants must submit a letter to OVW's Director, signed by the Authorized Representative, certifying that Federal funds will not be used to supplant state or local funds should a grant award be made. Please refer to <u>http://www.ovw.usdoj.gov/docs/nonsup_letter.pdf</u> for a sample letter. This should be a separate attachment to the application in Grants.gov.

Financial Accounting Practices

Each applicant must prepare a response to the following questions. OVW will review the applicant's responses to assist in evaluating the adequacy of the organization's financial management system and to identify areas of need for training and technical assistance. This section of your application should be no more than two pages and should be a separate attachment to the online application in Grants.gov.

- Will all funds awarded under this program be maintained in a manner that they will be accounted for separately and distinctly from other sources of revenue/funding?
- Does the applicant have written accounting policies and procedures? OVW may request a copy for review during the application/award process or as part of the grant monitoring process.

All award decisions are final.

OVW reserves the right to deduct points for applications that are partially out of scope, including unallowable activities, for applicants who are out of compliance with a current OVW grant award or cooperative agreement, and for any activities that compromise victim safety or confidentiality.

An application that is deemed to be substantially out of scope, proposes a substantial number of activities that are unallowable, or proposes activities that pose a significant threat to victim safety or a serious breach of confidentiality, will not be considered for funding.

Review Process

OVW will subject all applications to a review process that is fair and based on the criteria outlined in this solicitation. OVW may utilize internal review, external review, or a combination of both.

Past Performance Review

In addition to the review process described above, applicants with current or recent (closed within the calendar year) OVW awards and/or cooperative agreements will be reviewed based on the elements listed below. Please note that if the applicant has not met or completed any one of the following, up to 25 points may be deducted from the application.

- Progress reports submitted by the applicant, in conjunction with monitoring conducted by OVW, that demonstrates the effectiveness of the current project, indicating timely progress toward meeting project goals and objectives;
- Demonstration that past activities supported with OVW grant funds have been limited to program purpose areas;
- Adherence to all special conditions of existing grant award(s) from OVW;
- Adherence to programmatic and financial reporting requirements, including timely submission of required reports;

- Completion of close-out of prior awards in a timely manner;
- Appropriate utilization and active participation in OVW-sponsored workshops and other technical assistance events as required by a special condition of the current award;
- Receipt of financial clearances on all current grants from OVW;
- Timely resolution of issues identified in any audit or on-site financial or programmatic monitoring visit;
- Adherence to the Office of Management and Budget single-audit requirement; and
- Timely expenditure of grant funds.

OVW grantees with significant past performance issues may not be considered for funding.

Compliance with OVW Financial Requirements

Each OVW grantee agrees to follow the financial and administrative requirements in the OVW Financial Grants Management Guide at <u>http://www.ovw.usdoj.gov/docs/gfmd-financial-grants-management-guide.pdf</u> as a condition of receiving grant funding. If OVW determines that a current grantee has violated any of the requirements of the Guide, the grantee may be denied continuation funding.

High Risk Grantees

Based on DOJ's assessment of each grantee with regard to current or previous funding, unresolved audit issues, delinquent programmatic and fiscal reporting, and prior performance, a grantee may be designated "high risk." Awards to high-risk grantees may carry special conditions such as increased monitoring and/or prohibitions on drawing funds until certain requirements are met. High-risk grantees with substantial or persistent performance or compliance issues, longstanding open audits, or open criminal investigations will likely not receive an additional OVW award until all issues are resolved.

Budget Guidance

Cost guidance for selected items is provided below to assist applicants in preparing the budget detail worksheet. In developing your budget detail worksheet please refer to the OVW Financial Grants Management Guide at <u>http://www.ovw.usdoj.gov/docs/gfmd-financial-grants-management-guide.pdf</u>.

Consultants/Contracts

Compensation for services by an individual consultant should be reasonable and consistent with that paid for similar services in the marketplace. Applicants should consider the type of services provided and the experience and expertise of the individual consultant when deciding if a consultant's rate is reasonable. Applicants are strongly discouraged from requesting consultant rates in excess of \$650 per day. Please note that this does not mean that the rate can or should be as high as \$650 for all consultants. If a project is ultimately selected for funding with a budget allocating more than \$650 per day to a consultant, the applicant must provide additional information to OVW for review and approval before consultant costs are incurred. Applicants should also include all costs associated with consultants/contracts in the "Consultants/Contracts" category, including travel-related costs. These costs should not be reflected in the Personnel or Travel categories.

Applicants should follow the same established procurement policies with Federal funds as they would with non-federal funds. All procurement transactions should be awarded in a manner that provides maximum open, free and fair competition, and must follow 28 C.F.R. §66.36 (if a State or local government) and 28 C.F.R. §§ 70.40-70.49 (if a non-profit, or an institution of higher education). All sole-source procurements (those not awarded competitively) in excess of \$100,000 require prior approval from OVW. This applies to procurements of goods and services, but not to compensation for MOU project partners for time spent working on program objectives.

Rent

Rental costs are generally allowable under OVW programs. Applicants should list square footage and cost per square foot in the budget. The amount must be based on the space that will be allocated to implement the OVW project, not the costs of the entire rental space. **Rental costs are not allowable for property owned by the applicant or if the applicant has a financial interest in the property**. In this case only the costs of ownership, including maintenance costs, insurance, depreciation, utilities, etc., are allowable costs. The applicant must indicate in the budget narrative whether or not they own the space that will be rented.

Audit Costs

Costs for audits not required or performed in accordance with the Office of Management and Budget (OMB) Circular A-133 are unallowable. If the applicant agency did not expend \$500,000 or more in federal funds during the organization's fiscal year, the cost of any audit performed may not be charged to the grant.

Indirect Costs

Applicants that have current, federally-approved, indirect cost rates may seek to claim indirect costs and must submit a copy of their current Federally-approved indirect cost rate agreement with the application. Applicants may choose to waive indirect costs.

Purchase and/or Lease of Vehicles

The purchase and/or lease of vehicles is prohibited under most OVW grant programs, although some programs allow for purchasing vehicles on a case-by-case basis. Please refer to the

solicitation for which you are applying to determine whether vehicles can be purchased or leased. If requesting a vehicle, a lease/purchase analysis must be submitted with the application.

Compensation for Partners

In developing the budget, applicants should compensate all project partners for their participation in any project-related activities, including but not limited to, compensation for time and travel expenses to participate in project development, training, and implementation. The budget **must** include compensation for all services rendered by project partners, including nonprofit, nongovernmental domestic violence and/or sexual assault victim services programs and state and tribal domestic violence and/or sexual assault coalitions. If a partner is a State or local governmental agency and the partnership duties are conducted within the course of the agency's "regular" scope of work, applicants do not need to compensate the partner if the partner a) offers this arrangement; and b) an explanation of this arrangement is included in the application.

Non-Federal contributions

Applicants are encouraged to maximize the impact of federal dollars by contributing to the costs of their projects. Supplemental contributions may be cash, in-kind services, or a combination of both. Any non-federal contributions can be discussed in the project narrative or Memorandum of Understanding (if required). Applicants should not include supplemental contributions in the budget, budget narrative, or SF-424.

Applicants are advised that if they voluntarily decide to provide matching funds through the use of in-kind contributions, and include this information in the budget or budget narrative, the voluntary contributions will become a mandatory requirement under the grant award. Grantees that fail to provide sufficient mandatory matching funds through cash or in-kind contributions during the award period may be required to meet their obligation by making a cash payment to the Office on Violence Against Women in order to close out the grant award.

The Investigator is an investigator with the tribal law enforcement agency. She/he will dedicate 100% of their time to investigating cases of domestic violence, sexual assault, dating violence and stalking that occur on tribal lands.

The Administrative Assistant for the project will be a part-time employee. She/he will be compensated at a rate of \$10/hour. The designated time spent on the project will be 20 hours each month providing administrative and clerical support to the staff of the Victim Services Program.

B. Fringe Benefits - Fringe benefits should be based on actual known costs or an established formula. The Sexual Assault Training manuals will be purchased from the Sexual Assault Resource Center and will be used in conjunction with the on-site training that will be provided by the Consultant/Trainer.

The Project Coordinator will develop and produce a Resource Manual for services both on and off the Reservation for victims of domestic violence, sexual assault, and stalking. Copies of the manual will be provided to all units of Tribal government and to victim services and social services agencies in the local community.

Many victims in the more geographically remote areas of the Reservation do not have long distance service, and it is a long distance call for most of them to the program office. The project will continue to operate an 800 hotline for victims. It will be staffed by volunteers on a daily basis.

The program has previously developed brochures explaining the dynamics of domestic violence and sexual assault and detailing the services offered by the program. Additional copies of the brochures need to be reproduced. Based on previous distribution patterns, it is anticipated that the program will distribute

1,000 copies of each brochure during the 36 month grant period.

The Victim Services Program rents a safe house that is located off-reservation in the local community. The house is used to provide temporary housing to victims of domestic violence and their minor children who are in need of a safe place to stay after fleeing an abusive situation. The rent is consistent with the fair market rate for similar properties in the local community.

The cost of utilities (i.e., gas, electric, and water service) averages \$200/month. The services are necessary to ensure that the house is suitable for occupancy.

Funds have been budgeted to provide transitional housing assistance to at least one victim of domestic violence, dating violence, sexual assault or stalking each month. Each victim and her dependents will receive up to \$500 to assist with rent and utility payments or security deposits.

APPENDIX B

Physical Modification Guidelines

Physical Modification

To honor the goal of the Disability Grant Program and build the capacity of organizations working as a multidisciplinary team to provide services to women with disabilities and/or Deaf women who are victims of violence and abuse, OVW requires that funds designated for physical modifications should not exceed 2% of the total award.

As of Fiscal Year 2007, applicants who are proposing to use 2% of Disability Grant Program funds for physical modifications must follow the following guidelines outlined in this solicitation.

Under the Disability Grant Program, OVW will consider the following to be physical modifications: building ramps, widening doorways, making a bathroom accessible, painting or carpeting and other seemingly insignificant modifications.

All OVW awards that involve physical modifications must comply with the National Environmental Policy Act (NEPA) (42 USC section 4321 et seq.) and the National Historic Preservation Act (NHPA), and any other applicable environmental statutes or regulations. DOJ has established procedures to implement NEPA at 28 CFR Part 61. Applicable NHPA regulations can be found at 36 CFR Part 800.

For OVW to undertake the necessary review under the NEPA and NHPA, those applicants proposing to use grant funds for any type of physical modifications must include the following information as an attachment to the application:

- A precise description of the proposed modification. The description must include the following information: the location of the facility; the age of the facility; an explanation of the prior and current use of the facility; a complete and detailed description of the planned modifications and the materials to be used; a statement as to whether the proposed modifications will change or materially alter the basic prior use of the building, or its size; a statement as to whether the facility is located on a 100-year floodplain or a wetland; and an explanation of the need for the proposed modifications;
- A letter from the State Historic Preservation Officer (SHPO), or Tribal Historic Preservation Office (THPO) indicating whether the building is listed, or eligible for listing, on the National Registry of Historic Places, and also certifying that no historic building will be affected by the proposed modifications;
- A statement by the applicant that the applicant has notified a representative of the local government with jurisdiction over the area potentially affected by the project, and made such official aware of the option to be consulted during the NHPA process; and
- A statement by the applicant as to whether there are any other known environmental concerns regarding the proposed modifications.

Applicants whose proposals do not include the aforementioned materials will be prohibited from using cooperative agreement funds to support physical modifications. Please note that applicants should submit to the SHPO the precise location of the facility, the age of the facility and the

detailed plans for the modifications, and should allow 30 days for the SHPO to respond as to whether any historic buildings will be affected.

Upon receipt of the information listed above, OVW will make a determination under both the NEPA and the NHPA as to whether further review is required. Specifically, after review of the proposed modifications, OVW will determine whether the NEPA requires completion of an Environmental Assessment (EA) before proceeding with an award that includes the proposed modifications. At a minimum, proposed modifications that involve new construction, change the basic prior use of a facility or change its size, or that otherwise may affect the environment will require further review and the completion of an EA by the applicant before OVW will be able to make an award.

Additionally, OVW will make any necessary further determination under the NHPA, and will then make that further determination available to the relevant Tribal Historic Preservation Office (THPO) or SHPO, and must allow 30 days for response, as required by the NHPA regulations. Depending on the need for further review under the NHPA or the NEPA, the applicant should be aware that there may be a delay in the ability of OVW to make an award that includes the proposed modifications.
