





SEER Observed Incidence, SEER Delay Adjusted Incidence and US Death Rates^a Cancer of the Larynx, by Race and Sex







SEER Observed Incidence and SEER Delay Adjusted Incidence Rates^a


SEER 9 Areas Compared to SEER 13 Areas

Cancer of the Larynx, Male, by Race





SEER Observed Incidence and SEER Delay Adjusted Incidence Rates^a



Cancer of the Larynx, Female, by Race




