





SEER Observed Incidence, SEER Delay Adjusted Incidence and US Death Rates^a Cancer of the Thyroid, by Race and Sex








SEER Observed Incidence and SEER Delay Adjusted Incidence Rates^a


SEER 9 Areas Compared to SEER 13 Areas

Cancer of the Thyroid, Male, by Race










