

U.S. EXPORT FACT SHEET

July 2010 Export Statistics Released September 9, 2010

EXPORT OVERVIEW:

- ➤ With the release of the July 2010 U.S. International Trade in Goods and Services report by the Department of Commerce's U.S. Census Bureau and the Bureau of Economic Analysis, U.S. exports of goods and services increased by 1.8 percent in July 2010 to \$153.3 billion since June 2010, while imports decreased 2.1 percent to \$196.1 billion over the same period.
- ➤ In July 2010, the monthly U.S. goods and services trade deficit decreased by 14.0 percent or \$7.0 billion to \$42.8 billion when compared to June 2010.
- ➤ U.S. goods and services exports through the first seven months of 2010 are up 17.9 percent to \$1,044.2 billion from the \$885.8 billion in exports through the same period of 2009.
- ➤ In July, the average import price per barrel of crude oil was \$72.09 per barrel; this is up from the low of \$39.14 per barrel in February 2009, and down from the June 2010 price of \$72.44. The slight decline in the value of crude oil imports since June was due to a 0.1 percent decrease in the crude oil import quantity (down to 311.7 million barrels) and a decrease of \$0.35 (or 0.5 percent) in the unit price per barrel.

TRADE SPOTLIGHT: U.S. Trade with Next Tier Markets

- ➤ Colombia, Indonesia, Saudi Arabia, South Africa, Turkey, and Vietnam are identified by the Trade Promotion Coordinating Committee (TPCC) as markets where U.S. companies have increasing opportunities in the next five to ten years as having high growth rates, a reasonable business climate, and significant export opportunities.
- ➤ The TPCC agencies identified these countries as markets where agencies could work closely together to develop a strong trade promotion program, including identifying opportunities for U.S. companies, ensuring U.S. companies are aware of the opportunities, and addressing market access barriers affecting sales.
