Training for new Commodity Supplemental Food Program (CSFP) State agency staff will be held January 26-27, 2010, at the Food and Nutrition Service (FNS) National Office in Alexandria, Virginia. This training affords new staff an ideal opportunity to learn more about the program and exchange ideas with your counterparts. If you are new to CSFP, I hope you can attend! Attendees will acquire knowledge and skills that will enable them to do their jobs more effectively. Alexandria, VA

> It is particularly important that staff from the new CSFP States -- Arkansas, Delaware, Georgia, Maine, New Jersey, Oklahoma, and Utah-attend this important event. These individuals will receive priority consideration based on available seating. Other State agencies should carefully consider whether their staff need the training this session provides. Training topics will include program regulations and legislation, the caseload allocation process and waiting list guidance, food ordering and the Electronic Commodity Ordering System (ECOS), inventory management, program reports and the Food Programs Reporting System (FPRS), civil rights, and nutrition and older adults.

Attached are a tentative agenda and a document detailing lodging, transportation, and nearby restaurant options. With regards to lodging, FNS has worked with the Hilton Garden Inn Arlington/Shirlington, a brand new hotel near FNS National Office, to reserve a block of rooms at a reduced rate. However, the block is limited, so it is advisable to make reservations quickly. More information is provided on the attached document. Also attached is a RSVP form that we request you and/or your State agency staff complete. Please submit the RSVP form to FNS National Office by close of business Friday, January 8, 2010.

It is important to note that new CSFP State agencies should not wait until the training to setup ECOS customer profiles, begin ordering food and certifying applicants, and ultimately work to serve participants as early as January 1, 2010. New State agency directors should work with their FNS Regional Office counterparts to initiate program operations to the maximum extent possible prior to the training. Regional Office staff are available to help ensure that you are meeting program requirements.

Use of Federal Administrative Funds

State agencies may use the Federal administrative funding provided by FNS for the administration of CSFP to send one new staff person from each State agency to attend the training. New State agencies may send more than one representative. Other State agencies may seek prior approval from the FNS Regional Office for the use of administrative funding for more than one State agency representative based on the State's individual circumstances. For example, approval may be granted if it is necessary and reasonable for additional representatives to attend based on their experience and the comprehensive training provided. FNS cannot provide additional Federal funding for

training attendance. FNS will inform each agency of its total administrative grant prior to January 1, and will release the funding to States as soon as it is available.

The training is not intended for local agency staff. However, new CSFP State agencies have the discretion to approve the requests for the use of Federal administrative funding to support the attendance of representatives from their local agencies, within their available funding allocations and the above guidelines. As provided above, seating is limited for this training, so discretion should be used when inviting local agency staff.

I hope that new State agency staff will give serious consideration to attending this important training. I am sure you will find the sessions and dialogue invaluable.
