RPT-009A	Imported Records	A list of records imported into SEER*DMS during a specific time period or for a certain facility.
RPT-013A	Abstracting Assignments	The Abstract Facility Leads (AFL) in a single AFL group. This is an assignment sheet given to an abstractor. A second version of this report has been provided as an external report. If registry-specific data fields are required on the assignment sheet, modify the external version (RPT-DT071A).
RPT-015A	Record Counts by Abstractor	Initial, follow-up, and casefinding counts by abstractor.
RPT-017A	Casefinding Completeness Log by Month of Diagnosis	CTC counts by month for a two-year period. Use this report to identify under-reporting by comparing the frequencies for the current reporting year with the previous year.
RPT-018A	Casefinding Completeness Log by SEER Site Recode	CTC counts by SEER site recode for a two-year period. Use this report to identify under-reporting by comparing the frequencies for the current reporting year with the previous year.
RPT-019A	Death Certificate Only CTCs by Year of Diagnosis	Frequencies and percentages of CTCs that are DCO by year of diagnosis. The early years can be collapsed into one year range (typically thru 1972).
RPT-020A	DCO Listing By Source	A list of the death certificate records that require follow-back; follow-back letters cannot be autogenerated because of missing physician information.
RPT-020B	DCO Listing By Source: Patient Sets	A list of the death certificate only CTCs in the patient set data. These are listed by source (facility, physician, or medical examiner).

RPT-040A	Print Filtered Worklist	The listing generated when the worklist print button is clicked. It displays the tasks that are currently selected and includes tasks from all pages.
RPT-054A	Patients by Number of Tumors	Shows the number of patients with 1 tumor, the number of patients with 2 tumors, etc.
RPT-061A	Workflow Location of Imported Records	A table displaying the current location of records in the workflow, paged by the import data file which contained the original record.
RPT-062A	Workflow Tasks	Current workflow tasks by diagnosis year and task type.
RPT-063A	Number of Linked Records	Frequencies of linked records by year of diagnosis, record type, and facility.
RPT-064A	Frequency of Edit Errors in the Patient Set Data	Counts of edit errors in the patient set data (CTCs) for a specified year range (based on date of diagnosis).
RPT-066A	Patient to Patient Matching	The report generated by the Patient to Patient Matching system task.
RPT-067A	Casefinding Patient/CTC Autobuild	The report generated by the Build CFOs system task.
RPT-068A	Death Cert Patient/CTC Autobuild	The report generated by the Build DCOs system task.
RPT-069A	Letter Communication Report	A template used for the letters and faxes generated within SEER*DMS.
