Purpose

This document defines the release of build **2009-04** of Grants.gov, It includes the scope, estimated schedule, identifies risks or impacts, functional release notes, as well as recommendations for mitigation and management. In addition, this document provides Acceptance Testing release notes, operational release notes, and Functional Test Cases that satisfy requirements associated with Deliverables 4.5.1 and 4.5.2.

Background

Software changes are collected from various sources as System Change Requests (SCRs) in the PVCS Tracker System. SCRs are categorized and go through a review process established by the Internal Control Board (ICB) of Grants.gov. SCRs gain approval through this process for inclusion in a Build.

Scope

The details of each SCR are listed in Appendix A, Operations Release Notes listed in Appendix B, and test cases for each SCR are listed in Appendix C. Below is the list of SCR's approved by the ICB to be included in release 2009-04:

Known Issues:

SCR 8826: Allow Grantors to view closing limits on closing dates.

Due to the Inflow suit framework the link Closing limit calendar on the left menu can only be placed on the top after set agency or above log out. This is due to permission granted to all grantors so it is published with basic menu that is driven by permissions and limited to the inflow suite code.

SCR 8855: Allow applicants and E-Biz POC to view forms and attachment file names received in applicant submission.

The back button was implemented via the web browser; the inflow suit framework does not permit the back button to work properly leaving the session and the previous page displayed. The browser back button will keep the session active and will navigate the user back to View all submitted application screen.

In the TINSTRUCTIONS table, MIMETYPE field length is increased from 50 to 250 characters.

The size limit for 3-digit extension had a standard limit of 32 characters for the MIMETYPE this was increased through the application and DB to 250 characters.
