The SNAP Hunger Champions Program honors local social services offices for providing exemplary service to clients.

The Food and Nutrition Service (FNS) supports an ongoing national media campaign to promote the Supplemental Nutrition Assistance Program (SNAP). There is a toll-free SNAP information hotline, a website for a quick, confidential eligibility screening, and free outreach materials.

There are hundreds of food banks, community and faith-based groups, and other organizations nationwide that help people learn about and apply for SNAP benefits. FNS formed the Outreach Coalition in 2003 to join forces with those efforts. By working together, we have created a strong national community of people fighting hunger and promoting nutrition.

Recognized for training Section 8 Housing staff to assist enrollment for SNAP; maintaining a worker dedicated to outreach at food pantries, churches, clinics, homeless encampments, and residences of homebound; leadership in providing service to LEPs; and office improvements that enhance customer service.

Mendocino County HHSA, Ukiah, California

Recognized for spearheading the *Food For All Mendocino* collaborative of local nonprofit and government agencies; training 30 advocates to assist enrollment in their organizations; establishing service sites in isolated areas and public health offices; and, thereby, increasing mail-in applications by 170 percent and the number of SNAP recipients in the county by 52 percent over two years.
