#### 1. Please describe significant project accomplishments completed during this quarter (600 words or less).

Environmental assessment (EA) processes continued through this quarter. The California Environmental Quality Act (CEQA) study was completed and adopted as a Negative Declaration by the California Public Utilities Commission (CPUC) on July 14, 2011. The National Environmental Policy Act (NEPA) final EA study was submitted to National Telecommunications and Information Administration (NTIA) for review. Federal agency concurrence and initial notification of a Finding of No Significant Impact (FONSI) was received on September 30, 2011. CVIN has hired additional key staff members including a CAD Specialist, Construction Accountant, and Network Manager in anticipation of beginning project construction early in quarter four of 2011. CVIN is also preparing to hire Network Specialists and Construction Inspectors. Detailed project engineering is completed. The project has been broken down into 30 construction segments. The first segment was bid out to construction contractors on August 30, 2011 and final competitive bids were received on September 27, 2011. Several additional segments have been bid out and are awaiting bid submittals from construction contractors. Additional pre-bid conferences have been conducted to qualify new construction contractors to participate in upcoming construction bids. Initial orders for conduit and fiber optic cable have been placed and are staged for immediate delivery. All grant fund expenditures this guarter are included in our approved 10-month Extended Procurement Budget.

One of the greatest challenges for CVIN which delayed the Final Environmental Assessment (EA) submission to the NTIA to complete NEPA and obtain the FONSI was the delay in receiving the final concurrence letter from the USFWS. The NTIA officials assisted CVIN by outreaching to USFWS to receive the final letter of concurrence on September 14, 2011. This allowed CVIN environmental consultants to finalize the EA for NTIA. CVIN commends the exceptional effort and support provided by NTIA to assist CVIN on reaching a major milestone. CVIN has submitted a number of construction permit applications with various jurisdictions for review and

CVIN anticipates the delivery of additional materials and the commencement of construction. In addition, CVIN anticipates conducting the first public ground-breaking ceremony to include various public and community officials. CVIN anticipates contracting biological and cultural resource specialist to monitor construction activities for compliance to both CEQA and NEPA Plans. In addition, CVIN anticipates hiring Construction Inspectors to monitor construction contractor activities. CVIN anticipates completing various permitting agreements and additional construction segment contracts to progressively advance construction. We intend to have at least 100 miles of new network deployed and 185 miles of upgraded network, but won't have any leased network miles yet. We will have two signed agreements with last mile providers but won't be in a position to connect any CAI's yet. There have been some slight adjustments in Budget Classifications which will remain under 10% of the total budget. We will work with our Grants Officer to address any budget updates that need to be reflected on next quarter's PPR.
