Acting Comptroller Testifies on Foreclosure Issues

Acting Comptroller John Walsh testified December 1, 2010, on regulation of national bank mortgage servicing operations and foreclosure processes before the Senate Committee on Banking, Housing, and Urban Affairs. <u>View his testimony</u>.
